

Special terms and condition

1. Contractor shall provide Single make in each material segment for the uniformly throughout HIG 01 & 03 and should be quoted accordingly All items must be ISI marked
2. **Work Completion schedule:** Work to be completed within 15 days of releasing of Work order.
3. **Risk Purchase:** In case, contractor does not carry out the works as per works completion schedule, in order to safeguard its interest under the contract, BHEL, at its own discretion, may get the services/repair/replacement of spares done through suitable alternative source(s) at risk & cost of the contractor. In such cases, any cost incurred to BHEL over and above contracted rates shall be recovered from dues payable to the contractor and no claim of compensation of loss, whatsoever, incurred by the contractor due to such recovery, shall be entertained by BHEL.
4. **Warranty:** 6-month warranty of materials and workmanship.
5. **Payment Terms:** Payment towards work satisfactorily executed will be made to the contractor through e-payment to contractor's account with 45 days (bill processing time shall be 10 days by MNT deptt. & 35 days by FIN deptt.) of submission of bill & verification of work by BHEL.
6. LD clause having penalty on late delivery @0.5% per week, which will be applicable if works not get completed within delivery schedule.
7. All old wiring material like switch boards, switch & sockets, wires etc will be handed over to BHEL
8. L1 will be decide on overall basis.
9. Final Qty. may be increase or decrease by +-5%.

Annexure-I**Scope of Work**

1. Removal of existing surface Casing Capping including copper wiring
2. Fixing of new copper wiring in underground conduit at the location of existing wiring.
3. Civil work including slot cutting in wall for fixing in conduit.
4. Plaster work & touchup paint work will be done by BHEL.
5. Complete rewiring work & replacement with all material like switch boards, switch & sockets, wires, conduit etc. as per specification in Annexure III at BHEL Township HIG 01 & 03. Rewiring work will include
 - a) Replacement of MDB
 - b) Redesigning of new circuits as per BHEL requirements.
 - c) Complete circuit Wiring from MDB to Light & Fan switch boards & Power Points.
 - d) Complete point wiring from switch boards to Light, fan & other points
 - e) Inverter wiring for all Switch boards
 - f) Wiring for Earthing in each Light fan & Power Circuits to Boards & in Half points
