Scope of Work:

The scope of work is inclusive of routine preventive maintenance to be carried out fortnightly (twice in a month) preferably on 2nd Saturday and last Saturday of every month and attending of complaint on emergency basis within 4 hours from the time of lodging of complaint.

Our Fire Alarm System consists of the following:

1.	Main Fire Panel Board (Agni Make)	01 No.
2.	Smoke & Heat Detector (Apollo Make)	270 Nos.
3.	Manual Call Points (Agni Make)	16 Nos.
4.	Hooters (Agni Make)	08 Nos.

The routine maintenance is inclusive of labour, visiting charges and all required materials/accessories like Acid, Distilled Water, Cotton, Duster etc.

Spare parts needed to replace faulty/ worn out parts shall be provided by BHEL.

INSTRUCTIONS TO BIDDER:

1. EMD amount of ₹ 1200.00 needs to be deposited through NEFT. The bank account details of BHEL for NEFT are enclosed as Annexure V. The bidder is required to enclose a copy of the acknowledgement of NEFT payment along with their bids. Bids without EMD will not be accepted and shall not be considered for further evaluation.

The EMD of unsuccessful bidders shall be returned within 15 days of award of work to the successful bidder. No interest shall be payable on EMD amount.

The EMD shall be forfeited in case of:

- i. After opening the tender, the bidder revokes his bid within the validity period or increases his earlier quoted rates.
- ii. The successful bidder does not commence the work within the period as per LOI / contract. In case the LOI / contract is silent in this regard then within 15 days after the award of contract.
- 2. Bidder is required to enclose copies of their GST registration, PAN card and a cancelled cheque.
- 3. The offer shall be submitted as per the instructions of tender document. One set of tender document duly signed and stamped on each page shall be submitted as detailed further. Tenderer should note specifically that all the pages of tender document, including the NIT page for this particular tender shall be submitted by them (after signing/ stamping on each page) as a part of their offer. In case of any clarification, bidder may contact this office.
- 4. The tenderer should accept all terms & conditions of the tender unconditionally. Tenders with deviations from terms and conditions shall be rejected.
- 5. In case any typing error/other clerical errors is noticed by the tenderer, in the tender documents, the same must be pointed out and got clarified before submission of offer, or else, BHEL's interpretation shall prevail and shall be binding on the tenderer.
- 6. No overwriting / correction in tender documents by tenderer shall be allowed. However, if correction is unavoidable, the same must be signed.



- 7. Only rate shall be quoted in price bid format (Annexure IV) and nothing else. Rates must be quoted in figures as well as in words. In case the rates in figures differ from the rates written in words, the lesser of the two will be treated as valid rate. Any other terms and conditions mentioned in the Price Bid shall make the offer liable for rejection.
- 8. The prices quoted should be inclusive of labour charges, visiting charges and all required materials/ accessories like Acid, Distilled Water, Cotton, Duster etc.
- 9. Spare parts needed to replace faulty/ worn out parts shall be provided by BHEL.
- 10. The prices quoted should be firm and no revision of prices will be entertained after the quotation is opened.
- 11. Tender must be submitted in a sealed envelope which has to be super-subscribed with NIT no. and due date written on the envelope and the bidder details.
- 12. Offers shall be received up to 1500 hours on 29.07.2019 and the same shall be opened same day at 1500 hours in presence of bidders who would like to be present. On the date of opening of tender, whole tender shall be opened.
- 13. Validity of offer will be 90 days from the date of opening of tender.
- 14. Tenders received late /in open condition/ not meeting the tender condition / incomplete in any respect are likely to be rejected.
- 15. Evaluation Criteria: The bidders shall be ranked on the basis of total amount calculated for two years from the item wise rates quoted by the bidders in the price bid. The work shall be awarded to L1 (lowest) bidder.

In the event of a miscalculation, the lower of the two values i.e. the correct value or the miscalculated value, shall be considered for evaluation and awarding the contract.

In the event of more than one bidder having quoted identical lowest rates and there is a tie amongst the bidders, the respective bidders would be asked to submit their revised rates. If distinct L1 rate isn't arrived at after submission of revised bids and the tie prevails between more than one bidders for Total Evaluated Cost, then the L1 will be decided based on lottery which will be carried out in the presence of all the L1 bidders or their representatives who choose to be present.

Final decision of BHEL on evaluation of bidders shall be binding on all the bidders.

- 16. BHEL reserves the right to accept or reject any or all offers without assigning any reason thereof. Also BHEL shall not entertain any correspondence from bidders in this matter.

CONTRACT TERMS & CONDITIONS:

- 1. **Subletting:** The Contractor shall not sublet, transfer or assign the full work or any part thereof to any other person/company/organization.
- 2. Validity of Contract: Validity of contract shall be 2 years from the date of start of work.
- 3. Payment Terms:

a) Payment shall be made after successful completion of services during every quarter.

- b) No advance payment or the payment for mobilization of work will be made to the contractor.
- c) Tax invoice raised by the contractor shall be certified by the official in-charge of BHEL and the 100% payment will be made within 15 days by NEFT/RTGS from the date of receipt of in discrepant bill.
- d) All payment will be subject to deduction of taxes at source as per rules.
- 4. The contractor shall not be entitled to any interest with respect to any money which may be due to him from BHEL.
- 5. Security deposit (SD) of 5% of the order value shall be deposited by the successful bidder either within seven days from the date of award of work or before start of contract whichever is earlier. The SD is to be deposited through NEFT in favour of BHEL, bank account shall be shared with the successful bidder.
 - SD, without interest, shall be refunded after successful completion of contract period.
- 6. **L.D. For Bad Quality of Services:** In case the services offered are not found satisfactory a 0.5 % per week subject to maximum 10% of total value will be deducted from the bill.
- 7. No excuses like hindrance because of extreme weather conditions, non-availability of labour and material etc. will be entertained for not providing services on time.
- 8. All necessary precautions with respect to safety at site and environmental aspects and their impacts shall have to be taken by the contractor for activities performed by his workers.
- 9. Arbitration / Conciliation: In the event of any dispute arising between the parties hereafter referred as BHEL and Contractor in respect of or connected with this contract, General & Special terms & conditions of tender, then the same shall be referred to Arbitration and Arbitrator will be nominated by the Head of Administration of BHEL Corp. Office, New Delhi, whose decision shall be final and binding on both the parties. However, any differences or doubt pertaining to meaning/ interpretation of any phrase word used in terms or in the schedule of services, their nature and manner of rendering of such services shall be the except ed matter and be referred to the Head of Administration of BHEL Corp. Office, New Delhi, whose decision shall be the final and binding. The provisions of Arbitration and Conciliation Act, 1996 or any statutory modification and re-enactment thereof will apply to such arbitration provided however, in all matters the venue of proceedings will be Delhi and only Delhi or appropriate Courts will have jurisdiction over the same.
- 10. Risk Clause: In case the contractor does not accept the work awarded to him or does not turn up after the award of work, BHEL shall have the right without any prejudice to get the work done through any other alternate agency at the risk and cost of Contractor. The additional cost including loss, if any incurred by BHEL will be recovered from the Contractor.
