### 2.0 **EARNEST MONEY DEPOSIT (EMD)**

- 2.1 Your offer shall be accompanied with a DD / Pay Order for Rs.19,000/- (Rupees Nineteen thousand only) drawn in favor of Bharat Heavy Electricals Limited, payable at New Delhi, towards EMD. Offers received without EMD shall be rejected. Refund of EMD of the bidders shall be as follows:
  - 2.1.1 EMD given by all unsuccessful Bidders shall be refunded normally within fifteen days of acceptance of award of work by the successful Bidder.
  - 2.1.2 EMD of the successful Bidder can be converted and adjusted against the Security Deposit on request in writing.
- 2.2 Bidders may please note that EMD carries no interest.

Bank Guarantees from co-operative banks/non-scheduled banks are not acceptable. Bidders to note that Security Deposit amount carries no interest.
- 3.2 The validity of Bank Guarantee towards Security Deposit shall be initially up to the completion period as stipulated in the LOI/PO + 45 days and the same shall be kept valid by proper renewal till the acceptance of Final Bills of the bidder by BHEL.
- 3.3 Security deposit shall be forfeited in case the successful bidder refuses to commence the work within the period as per LOI / Contract and/or any default, failure or neglect on part of the bidder in fulfilment of performance of the order.
