PRE-QUALIFICATION REQUIREMENTS FOR REFRIGERATION GAS DRIER

1. The refrigeration Gas Drier for drying or remove moisture from moist gas. Gas first cooled in gas to gas heat exchanger(precooler) in which secondary side dried cold gas flowing (going into the generator). After the pre-cooling, the compressed gas passes through evaporator in which deep cooling with refrigerant takes place upto 3-5 deg. C to condense moisture present in the moist gas. After this, the gas is passed through a separator system. The gas again passes through pre-cooler and is heated to about 25-40 deg. C for further use as moist free gas. Complete hermitically sealed compressor to be used with NON-CFC refrigerant. Heat exchanger (Precooler and Evaporator) should be of shell & tube type. For primary gas side, the pressure vessels and piping are designed for pressure 10kg/cm². The Ref. gas drier should be very reliable and proven design to maintain the required parameters in line with system requirements under all conditions.
2. The Vendor should be a regular manufacturer of such item and should have manufactured and supplied Re. Gas Drier with minimum following details:-
 - 2.1 The gas drier should have shell & tube type heat exchanger (Pre-cooler & evaporator) only.
 - 2.2 Flow of Primary gas medium should be 40 M³/Hr. (min.)
3. In support of above, vendor shall furnish their credential list, as per the following format for the past 7 years, with at least total supplied/commissioned of 10 nos. over past 7 years from the date of issuance of enquiry.

As soon as reasonably practicable following the date of commencement of a Force Majeure Event, and within a reasonable time following the date of termination of a Force Majeure Event, either Party invoking it shall submit to the other Party reasonable proof of the nature of the Force Majeure Event and of its effect upon the performance of the Party's obligations under this Agreement.

The party shall, and shall ensure that its Subcontractors shall, at all times take all reasonable steps within their respective powers and consistent with Good Operating Practices (but without incurring unreasonable additional costs) to:

- a) Prevent Force Majeure Events affecting the performance of the party's obligations under this Agreement;
- b) mitigate the effect of any Force Majeure Event; and
- c) Comply with its obligations under this Agreement.

If the war like situation has developed in a country where a seller's works is located in the P.O. or there is political instability and Indian Embassy located in that country forbids or advises for not having any business dealing with the sellers located in such zone / region/ country, then BHEL reserves the right to cancel the order.

20. NON-DISCLOSURE AGREEMENT.

All Drawing and Technical Documents relating to the product or it's manufacture submitted by one party to the other, prior or subsequent to the formation of contract, shall remain property of the submitting party. Drawing, technical documents or other technical information received by one party, shall not without the consent of the other party, be used for any other purpose than that, for which they were provided. Such technical information shall not without the consent of the submitting party, otherwise be used or copied, reproduced, transmitted or communicated to a third party. Patterns supplied by BHEL will remain BHEL's property which shall be returned by the bidder on demand to BHEL. The seat or place of arbitration shall be New Delhi, India. The language to be used in the arbitration shall be English. The governing law of the contract shall be the substantive law of India. In case the parties fail to agree on the appointment of arbitrator within 2 months of the notice invoking arbitration by one party, then the

- d) Contamination of Radio Activity from any nuclear fuel or from any other nuclear waste or any other hazardous materials.

Drawing, technical documents or other technical information received by one party, shall not without the consent of the other party, be used for any other purpose than that, for which they were provided.
