SCOPE OF WORK:

The scope of work shall include collection of laundry items from individual seats/ different locations on the last working day of every week and place the same on respective seats/ locations after proper washing/ dry-cleaning on first working day of the following week.

The laundry items being used at BHEL, Lodhi Road are:

- Large towel**
- 2. Small towel
- 3. Bed sheet
- 4. Pillow cover
- 5. Chair cover
- 6. Car towel
- 7. Apron
- 8. Curtain (Roller blinds)

**Large towels are used on individual seats and in washrooms. The towels being used in the washrooms are to be washed and put up on daily basis. To facilitate the same, two sets of towels are being used in each washroom, so that when a towel is taken away for washing the other clean towel is put up in the washroom.

In the event of delay in delivering the washed items on first working day of the week, BHEL reserves the right to impose a penalty of ₹ 100.00 (One Hundred) per day of delay. However, in case the delay has been caused due to reasons that are beyond the control of contractor like incessant rains or wet weather conditions etc., BHEL may consider waiver of the said penalty charges.

The washing should be of good quality and to the entire satisfaction of the user. The material shall be collected and returned at BHEL, Lodhi Road office and no cartage or conveyance shall be paid by BHEL on this account. No payment shall be made by BHEL for items which are found to be of inferior washing quality. If any item is misplaced by the party, new item shall have to be provided by the contractor or purchase price for the same item shall be deducted from the contractor's bill.

INSTRUCTIONS TO BIDDER:

- 1. This is a two part bid tender, therefore, bidders are requested to read the complete tender enquiry document very carefully before submitting their bids.
- 2. EMD amount of ₹ 5400.00 needs to be deposited through NEFT. The bank account details of BHEL for NEFT are enclosed as Annexure VI. The bidder is required to enclose a copy of the acknowledgement of NEFT payment along with their bids. Bids without EMD will not be accepted and shall not be considered for further evaluation.

The EMD of unsuccessful bidders shall be returned within 7 days of award of work to the successful bidder. No interest shall be payable on EMD amount.

The EMD shall be forfeited in case of:

i. After opening the tender, the bidder revokes his bid within the validity period or increases his earlier quoted rates.



- ii. The successful bidder does not commence the work within the period as per LOI / contract. In case the LOI / contract is silent in this regard then within 15 days after the award of contract.
- 3. Bidder is required to enclose copies of their GST registration and PAN card.
- 4. The offer shall be submitted as per the instructions of tender document. Tenderer should note specifically that all the pages of tender document, including the NIT page for this particular tender and unpriced bid, shall be submitted by them (after signing/ stamping on each page) as a part of their offer. - 5. The tenderer should accept all terms & conditions of the tender unconditionally. Tenders with deviations from terms and conditions shall be rejected.
- 6. In case any typing error/other clerical errors is noticed by the tenderer, in the tender documents, the same must be pointed out and got clarified before submission of offer, or else, BHEL's interpretation shall prevail and shall be binding on the tenderer.
- 7. No overwriting / correction in tender documents by tenderer shall be allowed. However, if correction is unavoidable, the same must be signed.
- 8. Only rate shall be quoted in price bid format and nothing else. Rates must be quoted in figures as well as in words. In case the rates in figures differ from the rates written in words, the lesser of the two will be treated as valid rate. Any other terms and conditions mentioned in the Price Bid shall make the offer liable for rejection.
- 9. The prices quoted should be inclusive of labour charges or conveyance and nothing shall be paid extra by BHEL on this account.
- 10. The prices quoted should be firm during the period of contract and no revision of prices will be entertained.

PRE-QUALIFYING REQUIREMENTS (PQR):

1. EMD amount of ₹ 5400.00 needs to be deposited through NEFT. The bank account details of BHEL for NEFT are enclosed as Annexure VI. - 4. The experience of having successfully completed similar jobs / services for MNCs/ Central or State Govt. offices/ PSUs during last 7 years ending on 30.11.2017 should be either of the following:
 - i) Three similar completed jobs / services with value not less than ₹ 1.08 Lakhs each.

Or

ii) Two similar completed jobs / services with value not less than ₹ 1.35 Lakhs each.

Or

iii) One similar completed job / service with value not less than ₹ 2.16 Lakhs.

"Similar Job / service" refers to "Rate Contract for washing / dry cleaning of office laundry for BHEL, Lodhi Road, New Delhi."

Only work orders and related work completion certificates from the clients shall be submitted as proof against Sl. No. 4 of PQR. For example: If you are qualifying as per Sl. No. 4 (ii), only work orders and related work completion certificates of 2 clients each costing not less than ₹ 1.35 Lakhs shall be furnished. The work completion certificate shall be specific to the work order submitted i.e. the specific contract, value of the job, duration of contract / job and declaration of satisfactory performance shall be indicated in the work completion certificate from the client. The certificates shall be issued by competent authority with his / her contact details mentioned, for verification purpose. BHEL reserves the right to verify the correctness of the certificates of the clients.



EVALUATION CRITERIA:

- 1. The techno-commercial bids i.e. Part-I submitted by all the bidders will be evaluated first. After techno-commercial evaluation, only the price bids of the bidders who qualify the techno-commercial evaluation will be opened on a subsequent date. The date of opening of price bids shall be intimated to the concerned bidders through email.
- 2. In the price bid, the bidders are required to quote item wise rate for each item mentioned in Price Format (Annexure V) in the space provided and accordingly evaluate the total expenditure on each item in two years.
- 3. The ranking of the bidders shall be made on the basis of total amount calculated for two years from the item wise rates quoted by the bidders in the price bid.
- 4. In the event of a miscalculation, the lower of the two values i.e. the correct value or the miscalculated value, shall be considered for evaluation and awarding the contract.
- 5. In the event of more than one bidder having quoted identical lowest rates and there is a tie amongst the bidders, the respective bidders would be asked to submit their revised rates. This process would continue till the distinct L1 (lowest) rate is arrived.
- 6. Work will be awarded to the L1 bidder and final decision of BHEL on evaluation of bidders shall be binding on all the bidders.
- 7. Tender may be rejected on account of unsatisfactory past performance in the execution of an earlier contract if noticed during technical evaluation.

PROCEDURE FOR SUBMISSION OF BIDS:

The bidders must submit their duly completed offers in a sealed envelope (Envelope #1) prominently super-scribed as "Offer for rate contract for supply of flower arrangements BHEL, Lodhi Road" followed by tender reference and last date for submission of tender.

Inside sealed Envelope #1, two separate sealed envelopes viz. Envelope #2 and Envelope #3 are to contain two parts of the tender "Part-I: Techno-commercial Bid and Earnest Money Deposit" and "Part-II: Price Bid" respectively. Both the sealed envelopes are to be super-scribed with "Part-I" or "Part-II" whichever is applicable, tender reference and details of the bidder.

CONTRACT TERMS & CONDITIONS:

- 1. **Subletting:** The Contractor shall not sublet, transfer or assign the full work or any part thereof to any other person/company/organization.
- 2. Validity of Contract: Validity of contract shall be 2 years from the date of start of work.
- 3. **Quantity:** The quantities provided in Price Bid format are tentative in nature which may vary as per requirement, however, the payment shall be made on actual basis.

4. Payment Terms:

- a) Payment shall be made after successful completion of services during every month.
- b) Neither any advance payment nor any payment for mobilization of work will be made to the contractor.
- c) Tax invoice raised by the contractor shall be certified by the official in-charge of BHEL and the 100% payment will be made within 15 days by NEFT/RTGS from the date of receipt of in discrepant bill.
- d) All payment will be subject to deduction of taxes at source as per rules.
- 5. The contractor shall not be entitled to any interest with respect to any money which may be due to him from BHEL.
- 6. **Security deposit (SD)** of 5% of the order value shall be deposited by the successful bidder either within seven days from the date of award of work or before start of contract whichever is earlier. The SD is acceptable only through NEFT in favour of BHEL, bank account shall be shared with the successful bidder.
 - On request of successful bidder, the amount deposited as EMD shall be adjusted against SD and remaining amount of SD shall have to be deposited by bidder as above. SD, without interest, shall be refunded after successful completion of contract period.
- 7. **Termination of contract:** If at any time the contractor defaults in performance of the work with due diligence and continues to do so or commit any default in complying any of the tender terms and condition even after the notice in writing is given, BHEL may, without prejudice to any other right to remedy which shall have accrued or shall accrue thereafter to BHEL, terminate the contract by giving 15 days' notice in writing. The notice will be deemed to have served as and when sent to the address given in the tender. In such a case, the Security Deposit shall be forfeited.
- 8. Penalty: In the event of delay in delivering the washed items on first working day of the week, BHEL reserves the right to impose a penalty of ₹ 100.00 (One Hundred) per day of delay. - 11. **Arbitration:** In the event of any dispute or difference arising out of the execution of the Order/Contract or the respective rights and liabilities of the parties or in relation to interpretation of any provision between BHEL & Service provider in any manner touching upon the Order/Contract, such dispute or difference shall (except as to any matters, the decision of which is specifically provided for therein) be referred to the arbitration of the person appointed by the competent authority of BHEL.
 - Subject to as aforesaid, the provisions of Arbitration and Conciliation Act, 1996 (India) or statutory modifications or re-enactments thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause. The venue of arbitration shall be at New Delhi.
- 12. Laws governing the contract: The Order/Contract shall be executed and governed by the laws of India and the courts of India alone shall have jurisdiction in respect of any matter arising under or in connection with the Order/Contract.
- 13. Jurisdiction of court: Courts at Delhi/New Delhi shall have exclusive jurisdiction to decide the dispute, if any, arising out of or in respect of the contract (s) to which these conditions are applicable.
- 14. **Risk Clause:** In case the contractor does not accept the work awarded to him or does not turn up after the award of work, BHEL shall have the right without any prejudice to get the work done through any other alternate agency at the risk and cost of Contractor.
