Rate contract is proposed to be done with 2 vendors in ratio of 70:30 value wise at L1 FOR site price for this package (BHEL will try to ensure % split mentioned above, however % of splitting of RC between 2 vendors may be changed during ordering process for reason such as if L1 bidder is not customer approved etc.). However, order for a project shall not be split and will be placed on single vendor.

L1 Rates shall be counter offered to vendors (L2, L3 & so on) in succession. If none accepts L1 rates, RC shall be done with L1 vendor for 100% value.

37. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
- Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. 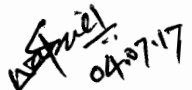
