- 3. BHEL will provide approx. 3 4 test sample per month to test lab and subject to 40 samples in one year for testing of particle size (NAS 1638).
- 4. Providing the sample at test laboratory is in the scope of BHEL.
- 5. Bidder must have **valid NABL accreditations certificate** for their Labs. Copy of certificate will be required along with offer.
- 6. Period of contract will be one year.
- 7. CFFP / BHEL reserve the right for ± 20 % variation in no. of samples and contract period.
- 8. Security deposit will be collected before start of work from the successful bidder, amounting to 10% of work contract value.
