- 4. **LD**: For delay in repair work, penalty shall be levied at 0.5% per week (or part thereof) subject to maximum of 10% of total order value.
- 5. Payment: Payment shall be made to the vendor through NEFT within 7 days after completion of the repair work and only after submission of GST compliant Tax invoice.
