

(c) SMALL EQUIPMENTS

(d) CHECKING OF RELAYS

This includes all relays installed in HT and LT panels in substation and test plant equipments. The work involves cleaning and shifting of relay from panel, testing of relay, record keeping and refitted in panel.

(e) CHECKING OF TRANSFORMER OIL

Registration of testing in M.T.Lab, collection of oil from transformer, sending to M.T.lab, getting report and record keeping.

(f) CHECKING OF EARTH PITS:

Cleaning of earth pits, measurement the earth resistance, record keeping.

(g) CHECKING OF SUB-STATION BATTERIES

Monthly cleaning of sub-station batteries, preparation of distilled water, checking of battery voltage, electrolyte, tightening of connection, record keeping etc.

7.0 TERMS OF PAYMENT:-

- 7.3 Service tax will be paid; this will be as per Guideline of Gov. of India. At present the rate of service tax is 12.36 %. Contractor should be submitted challan copy of service tax deposit.

8.0 GENERAL TERMS & CONDITIONS

- 8.1 Contract shall keep all staff orderly in proper uniform and arrange to provide them the work of repair/ manufacture of spares in their idle times.
- 8.2 After award of contract ,the subjected work shall be started with in one week from the date of award in line with our tender condition.
- 8.3 No foreign/used/unused/scrapped/broken parts shall be left on area.
- 8.4 All used/worn-out/scrapped/replaced spares/parts shall remain the property of BHEL, Jhansi. These items shall be return to WE&S store.
- 8.5 BHEL, Jhansi shall not be liable for any compensation what so ever in the event of accident/injury to the persons employed by the contractor, however, First Aid facility shall be rendered free of cost.
- 8.6 Utmost care should be taken by the contractor to repair the items in proper way & with Quality workman ship so as to satisfy the safety requirements as per Factory Act, 1948 Section 19 & U.P. Factories Rules 1950 Rule 55-A & subsequent amendments enforced from time to time.

The Technical Bid Application (Annexure - I) and its enclosures (along with the Contractor's Obligations, General Terms & Conditions and copies of qualifying requirements) must be submitted in one sealed envelope superscripted as **"Tender for Providing assistance in the work for maintenance of Substation Equipments and Electrical facilities/installations in BHEL-Jhansi factory and Township. TECHNOCOMMERCIAL bid"**. EMD/Cost of Tender Document or Documents required as per qualifying requirements must be enclosed. CONTRACTOR'S OBLIGATIONS

A) CONTRACTUAL:-

Towards selection, control and supervision of employees:-

- (a) Contractor shall decide the number of employees to be deployed for execution of the work awarded to him and he or his authorized representative will be solely entitled to instruct such workers about the manner of carrying out the work as per the prescribed specifications and quality plan.
- (b) Contractor shall supervise the work allotted to him and to be carried out by his employees.
- (c) Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc. acceptable to concerned department.
- (d) Contractor to maintain appropriate records of his employees deployed to carry out the job(s). Contractor shall maintain neatly written, complete and legible registers, records, reports and returns for inspection by various authorities at short notice.
- (e) Contractor shall ensure Personal Accident Insurance (24x7) policy of Contract Workers from (Govt. under taking company). The coverage shall be of Rs. 5 lakhs per individual. The coverage shall be of 24 Hrs. (Accidental Death cover). The sum assured (Rs. 5 lakhs) shall become payable to the nominee in the event of death of insured person. In the event of death of any contract worker deployed by the contractor without proper insurance cover, the contractor shall be liable to pay Rs. 5 lakhs to the nominee/ legal heir of such deceased contract worker. In case of extension of contract premium of accidental insurance will be on actual subject to maximum of Rs. 300/- per individual per quarter. Gate pass of the contract labour shall be issued only after taking the Insurance Cover.
- (f) Contractor will ensure that the job is executed through his employees on his rolls and under no circumstances the contractor will neither deploy any casual employee to carry out the job nor shall sub-contract the job without prior written permission.
- (g) Contractor may apply for providing bus pass facility to his workmen. BHEL will consider such applications based on merits and availability of seats. Contractor would be responsible for depositing bus pass charges and penalties (if applied) of his/her workmen/staff etc. BHEL would have the right to deduct/recover the same in case of default by the contractor/supplier.
- (h) Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.

1.0 LABOUR LICENCE AND OTHER REQUIREMENTS:-






