#### **SECTION-1**

#### GENERAL CONDITIONS OF CONTRACT

#### 1. SCOPE OF WORK

#### **Details as below**

- 1) Providing the services for Doctor (one no's) & nursing staff/first aidder (two no's)
- a) Education qualification & experience for Male Doctor- Doctor should possess MBBS DEGREE with valid Medical Council of India registration. The Doctor should have post qualification experience of at least 1 year, preferably in industry. Copies of the above certificates have to be submitted along with the bid.
- b) Education qualification & experience for Male Nurse:- Nurses should have passed their Diploma in Nursing & Midwifery. The Nurses should have one year experience in Trauma care and emergency medicine..
- d) Working Time for Doctor: 9 AM to 6 PM including 1 hrs lunch break.
- e) Working Time for Nursing staff:-12 hrs shift operation (day & night Monday to Sunday) it maybe change depend up on the requirement of site & decided by BHEL Engineer-In charge.
- e) Emergency visit of doctor:- On call doctor should be visit at medical center /incident location & BHEL will not pay any extra amount in this regards.
- 2) Holidays for Doctor & Nurse:- one day weekly off is permitted as holidays.

#### 3) Recovery /penalty

Following rate of penalty is applicable which are non refundable.

- a) Non availability/delay in deputation of doctor -:- Rs 1000 per day.
- b)Non availability/delay in deputation of nursing staff:-Rs 700 per shift .
- **4**) The contract will be valid for a period of 18 months effective from the deputation of Doctor & Nursing Staff.
- 5) If the services of the agency are found to be unsatisfactory the BHEL reserves the right to terminate the contract by giving one-month notice.
- 6) The bidder may seek any clarification from BHEL before quoting and the bidder will be deemed to have understood the entire scope of work. Any interpretations of the terms of this tender by BHEL will be binding on the bidder.
- 7) The rates quoted will be exclusives of all taxes and duties.

- **8**) Accommodation & Meal:- bidder shall arrange accommodation & meal for Doctor & Nursing staff, BHEL will not pay any amount in this regards.
- 9) Conveyance:- bidder shall arrange the conveyance for Doctor & Nursing staff (accommodation point to first -aid center location which is inside the plant) for performing the duties at Wankbori unit#8 BHEL will not pay any amount in this regards.
- 10) The contactor has to submit all statutory compliance ,ESI & EPF challans, wage sheets, medical certificates, and safety training certificate for their workmen for obtaining HR clearance from BHEL & gate pass preparation, if applicable. The Contractor shall arrange for the gate pass for Doctor & Nursing staff at his expenses.
- 11) Refusal to perform duty by the Doctor & Nursing staff will be treated non-availability of Doctor & Nursing staff. The decision of BHEL's representative will be final for effecting such penalty after evaluating the merit of such incidence.
