2	Availability of in-house facility for manufacturing of forged items.	1. List of machinery facilities available for manufacturing forged items. 2. Valid Furnace calibration report for the temperature for fittings and flanges as mentioned in TDG:7430:002.	
3	Bidder shall have prior experience in successful manufacturing and supply of seamless items like Matching Piece/Reducer of minimum single piece item weight of 50 kgs in SA105 specification. Experience for Tee or Y Piece or Lateral will also qualify. Experience for supply in higher Grades (F11/F12/F22/F91/F92) is also acceptable. Supply experience being furnished shall not be prior to 3 years from the date of the Enquiry. For indigenous Start-ups and MSE bidders alone, prior experience is relaxed to last 4 years from the date of Enquiry. Supply experience post Part I bid opening date will not be considered.	Copy of PO, MTC's, invoice, packing list, LR and Inspection reports witnessed / reviewed by any reputed inspection agencies like IBR, BV, TUV etc. shall be furnished.	
4	Firm should have made a turnover of at least Rs. 2 lakhs for anyone of last 3 audited Financial Year (FY 2018-19, 2017-18 or 2016-17).	Bidders shall submit audited Company Financial statement- Balance Sheet and P&L statement for anyone of the past 3 years (FY 2018-19, 2017-18 or 2016-17) meeting financial turnover criteria. Bidder shall submit the latest audited balance sheet (FY 2018-19) also.	

Note-

- Only the bids fulfilling PQR will be considered for further Techno-Commercial evaluation.
- For indigenous Startups and MSE bidders, financial turnover criteria as per SI No 4 and prior experience criteria as per SI No 3 are relaxed as follows subject to bidder meeting technical and quality criteria of the PQR-
 - Financial turnover criteria w.r.t sl. No. 4 of PQR – Relaxed to Rs. 1 lakhs.
 - Prior experience criteria- Experience w.r.t Sl. No. 3 of PQR is relaxed as not to be prior to 4 years from the date of the Enquiry.
- Bidders proposing to avail said relaxation as indicated above shall submit applicable documentary proof along with Pre-Qualification bid. In case the required documents are not submitted by the bidder, no relaxation will be provided.
 - For Startups – Certificate of Recognition by Department of Industrial Policy & Promotion.
 - For MSE – Copy of UAM for MSE registration along with CA certificate for FY 2018-19.
