I. <u>ELIGIBILITY CRITERIA</u>

- 1. The Bidder should have valid Service Tax registration number (If applicable) otherwise has to submit a Self Declaration of "Non Applicability of Service Tax" (Format enclosed with this tender document) on their Company's Letter Head and **PAN Card**. Documentary proofs / Xerox copies are to be enclosed.
- 2. The agency could be a Proprietorship/ Partnership Firm/LLP/One person Company/Private Limited Company/Public Limited Company/Trust/Society in this line of service / business documentary proof / Xerox copy to be enclosed.
- 3. The Mini truck/Mini lorry shall have the load carrying capacity of minimum 2 Ton.
- 4. The date of registration of vehicle shall be on after 01.06.2009 for which Copy of RC Book details shall be submitted along with the offer.
- 5. The vehicle should have all other statutory requirements such as RC, FC, Insurance, Road Tax, permit etc., as per the government requirements, and the copy of these documents shall be submitted along with the offer.
- 6. The driver shall have driving license for the class of vehicle offered, issued by the competent authority. The driver should have all the statutory requirements as prescribed by the Govt. Documentary evidence for these shall be submitted along in the offer.
- 7. Contractor contact details like Cell phone no., Land line no., and email id with address shall be necessarily to be provided as these are the only source to communicate about the movement requirement. Without these details, daily contacting may not be possible.
- 8. Suitable insurance coverage for driver and cleaner shall be taken by the contractor and proof shall be submitted to BHEL on award of contract and before starting of activities.
- 9. Only those bidders, who are meeting all the above qualifying criteria, will be considered for further evaluation and others will be summarily rejected.

SPECIFICATION OF MATERIAL TO BE TRANSPORTED

Any item related To BHEL Production Activities/Liveries items, Viz., Steel pipes, Steel fittings, Wooden logs, Furniture's, Stationeries, Machineries, Spares, Industrial Consumables, Oil Barrels filled with Diesel/Empty and other industrial items in these category.

BHEL SCOPE:

- 1) Identify the item that requires to be transported.
- 2) Making gate passes and other documentation.
- 3) Wherever manual loading/unloading is not feasible additional assistance will be provided by BHEL, free of cost.

CONTRACTORS SCOPE:

- 1) Placing of Mini truck /Mini lorry as per BHEL required date, time and location.
- 2) Loading of materials into Mini truck/ Mini lorry.
- 3) Co-operation at security point(s) and gets the materials verified by security personnel.
- 4) Safe transportation of materials to the destination.
- 5) Unloading of materials in the required unloading point(s) at the destination.

III. WORK SPECIFIC TERMS & CONDITIONS:

- 1) The vehicle shall be in good working condition. Transporter shall submit Vehicle details like Regn.no. Capacity, make, type and model year and Driver details like Name, age, experience, his contact no., during offer stage itself, and shall be maintained throughout the contract period.
 - In case of change, due to any unforeseen reasons, permission shall be obtained from PPPU MM Executive in advance. Also contractor shall do alternate arrangement for safe and timely delivery of materials at the cost and risk of the contractor.
- 2) The rate shall be quoted per trip basis i.e. from BHEL Trichy to BHEL, Thirumayam or vice versa. The rate quoted shall be inclusive of driver Bata, night halt, toll charges, entry charge, extra distance travel (due to road block, diversion of roads, etc.), and all other incidentals. No extra charges will be paid other than the rate per trip. Hence all inclusive charges per trip shall be quoted by the bidders.
- 3) The contractor shall hand over all the materials safely to the consignee with all the relevant documents that are given at the loading points. In case of damage or loss of either materials or documents, the cost for rectifying the damage/ loss will be recovered from the contractors running bills/ security deposit.
- 4) Required hood, tarpaulin sheet, etc., shall be used to protect the BHEL materials during rain, etc., is under the scope of the contractor.
- 5) Suitable transit insurance shall be under the contractor's scope, for a value not less than Rupees 2.00 lakhs, which shall cover each trip.
- 6) The driver shall have mobile phone for communication.

- 7) If any requirement for vehicle on Sundays/ holidays, the same shall be provided by the contractor. No additional payments in any manner will be given by BHEL for this Sunday/ holiday operations.
- 8) The contract may cover approx.150 to 200 trips in one year. From BHEL/Trichy to BHEL/TMM will be considered as one trip and vice versa.
- 9) The payment will be made only for the actual number of trips. Acknowledgement shall be obtained for each trip and that should be submitted along with the bill.
- 10) The Contract will be for a period of one year from the date of commencement of work.
- 11) The contractor shall follow and comply with PF, Group Insurance and other statutory regulations as stipulated in Factory's Act and associated State as well as Central Governments' rules and regulations stipulated.
- 12) BHEL is in no way responsible for any loss of life or any injury caused to any of the contractor's work force or equipment while executing the above listed work at BHEL premises.
- 13) BHEL reserves the right to alter any of the terms & conditions of the contract and any such changes will be intimated to the contractor from time to time.
- 14) BHEL reserves the right to cancel and terminate the contract at any time without assigning any reason.
- 15) Adherence of Terms & Conditions as per the NIT of the subjected Works Contract.

IV. <u>COMMERCIAL TERMS & CONDITIONS:</u>

01. RATE:

- (a) The rates quoted should be valid for 90 days initially from the date of opening of the price bid/Reverse Auction Process. The rates of successful bidder should be valid for 1 Year from the date of commencement of the contract.
- (b) The rates quoted should be INCLUSIVE of service tax and any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.
- (c) All entries in the tender documents should be in one ink. Erasures and overwriting are not permitted. All cancellations and insertions should be duly attested by the Bidders concerned.
- (d) Rates should be quoted as per the Work / Rate schedule. Rates quoted in any other form will not be accepted and will be rejected.
- (e) Unit rates should be quoted in figures as well as in words for all the items shown in the attached schedule. Wherever there is a difference in the two, **the rates in words will be taken as final.**
- (f) It is necessary, that the Contractor has to visit BHEL with prior notice and seeks clarification, if any, before offering the most Competitive Rate for the subjected work.

02. PAYMENT TERMS:

The consolidated statements and Bills in triplicate shall be prepared by the Contractor for the services rendered in the previous month, during the first week of succeeding month and submitted to concerned **End User** & after due certification from **End User**, the bills will be forwarded to Accounts Section. The payment will be made through RTGS / EFT to the contractor immediately after the receipt of the error free bill. It is to be noted that it will take around ten days to process the bill at **End User** and Accounts section after submission.

03. CONTRACT PERIOD

- (a) The contract execution period will be for a period of **1 Year** from the date of commencement of work.
- (b) If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.
- (c) The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice. In the event of contractor requiring termination, he has to provide 4 months' notice to BHEL.

04. SECURITY DEPOSIT:

(a) Security Deposit should be paid by the contractor. Security Deposit shall be collected from the successful Bidder as shown below:

Contract Value Up to Rs.10 Lakhs : 10%

Above Rs.10 Lakhs up to Rs.50 Lakhs : 1 Lakh + 7.5% of the amount exceeding Rs.10 Lakhs Above Rs.50 Lakhs : 4 Lakhs + 5% of the amount exceeding Rs.50 Lakhs

The Contractor should remit the Security Deposit before start of the work, if the contract value is more than 10 Lakhs. The EMD amount shall be converted as security deposit and the balance amount shall be remitted. No interest will be paid to the Contractor for the amount deposited during the period of agreement.

Failure to pay the security deposit shall be treated as failure to discharge the duties under the contract and shall result in cancellation of the contract and the Bidder shall be liable to compensate BHEL for any losses incurred by BHEL. EMD in such cases shall be forfeited.

The security deposit shall be refunded within a reasonable time after the date of successful completion of the contract i.e. the Contractor carrying out all obligations / operations as required under the contract agreement.

BHEL reserves the right to appropriate any part or the whole of the amount of the security deposit without prejudice to other claims against this Contractor for losses suffered by BHEL due to failures on the part of the Contractor or due to termination of contract or Contractor becoming disqualified because of liquidation / insolvency or change of composition. The decision of BHEL in respect of such losses, damages, charges, expenses or costs, shall be final and binding on the Contractor and the decision shall not be questionable.

- (b) The Security Deposit may be submitted in any one of the following forms:
 - Cash (as permissible under the Income Tax Act)
 - Pay Order, Demand Draft in favour of BHEL.
 - Local cheque of scheduled banks, subject to realization.
 - Securities available from Post Offices such as National Savings Certificates, Kisan Vikas Patras etc. (Certificates should be held in the name of Contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back) and with minimum validity of covering the contract period.
 - Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL and with minimum validity of covering the contract period.
 - In order to ensure the genuineness of BG's, the BG's are to be sent directly by the concerned bank through registered post to Senior Manager / Contracts, Power Plant Piping Unit (PPPU), BHEL Thirumayam 622 507.
 - Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the contractor, A/C BHEL, duly discharged on the back and with minimum validity of covering the contract period.
 - Security deposit can also be recovered at the rate of 10% from the running bills. However
 in such cases at least 50% of the Security Deposit should be remitted (any of the above
 form) by the vendor before start of work and the balance 50% may be recovered from the
 running bills.

The security deposit shall not carry any interest.

The Earnest Money paid at the time of tender will be converted as part of the Security Deposit and the balance amount will be collected from the contractor as mentioned above.

Security Deposit shall not be refunded except in accordance with the terms and conditions of contract or tender enquiry. No interest shall be allowed on Security Deposits. BHEL shall not be responsible for any loss of securities, due to liquidation for any other reasons, what-so-ever or any depreciation in the value of the securities while in their charge or for any loss of interest there on.

All compensation or other sums of money payable by the Contractor to BHEL under the terms of this contract or under any other contract with BHEL may be deducted from the Security Deposit or realized by the sale of the securities or from the interest arising there from or from any sums which may be due or may become due to the contractor by BHEL and in the event of this Security Deposit being deducted by reason of such deductions or sale, as aforesaid, the Contractor shall within 7 days thereafter, make good in cash or in securities endorsed as aforesaid, any sum by which the Security Deposit has been reduced.

05. TENDER EVALUATION:

- (a) The Bidder should submit the details as per the Price Bid format only.
- (b) L1 will be decided on minimum of the total sum (A x B) for serial No. 1 of Price Bid on a Single vendor.
- (c) BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All

Terms & Conditions of Reverse Auction

Against this enquiry for the subject item/ system with detailed scope of supply as per enquiry specifications, BHEL may resort to "REVERSE AUCTION PROCEDURE" i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for reverse auction shall be English Reverse (No ties).

- 1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
- 2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit "online sealed bid" in the Reverse Auction. Non-submission of "online sealed bid" by the bidder for any of the eligible items for which technocommercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
- 3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.
- 4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
- 5. Business rules like event date, time, bid decrement, extension etc. also will be communicated through service provider for compliance.
- 6. Bidders have to fax the Compliance form before start of Reverse auction. Without this, the bidder will not be eligible to participate in the event.
- 7. In line with the NIT terms, BHEL will provide the calculation sheet (e.g., EXCEL sheet) which will help to arrive at "Total Cost to BHEL" like Packing & forwarding charges, Taxes and Duties, Freight charges, Insurance, Service Tax for Services and loading factors (for non-compliance to BHEL standard Commercial terms & conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.

- 9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal.
- 10. The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required, (Annexure VII) as provided on case-to-case basis to Service provider within two working days of Auction without fail.
- 11. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL"s standard practice.
- 12. Bidders shall be required to read the "Terms and Conditions" section of the auctions site of Service provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. Bidders should acquaint themselves of the "Business Rules of Reverse Auction", which will be communicated before the Reverse Auction.
- 13. If the Bidder or any of his representatives are found to be involved in Price manipulation/ cartel formation of any kind, directly or indirectly by communicating with other bidders, action as per extant BHEL guidelines, shall be initiated by BHEL and the results of the RA scrapped/ aborted.
- 14. The Bidder shall not divulge either his Bids or any other exclusive details of BHEL to any other party.
- 15. In case BHEL decides to go for reverse auction, the H1 bidder (whose quote is highest in online sealed bid) may not be allowed to participate in further RA process.

V. CONDITIONS RELATED TO THE WELFARE OF LABOURS:

- 1. BHEL will not be liable for any medical attention, injury / loss of life of the persons engaged by the contractor in the Supply of 2T Capacity Mini Lorry for the movement of materials from HPBP/Trichy to PPPU/Thirumayam & vice versa on hire basis as per the contract. A suitable insurance coverage for the staff of contractor shall be arranged by the Contractor at contractor's cost from the first day of operation, towards medical treatment and compensation of any loss to their workmen as per legal provisions.
- 2. The contractor shall have full control over his employees including the right to appoint, determine service conditions, discharge, dismiss, or otherwise terminate their services at any time. The contractor shall be solely responsible for any claim arising out of employment or termination of employment of his employees and for statutory payments.
- 3. The contractor shall employ such personnel who are medically fit and above the age of 18 only. The company has the right to direct the contractor to remove from the premises such of his personnel who may be physically, hygienically, clinically or medically found to be unfit.
- 4. The Contract workers should be fully aware of safety measures and observe all safety precautions during work. The contractor should also make his own arrangements to provide requisite safety devices to the workers, based on the nature of work. Any accident / incident occurring to his workers in Company's premises should be reported in writing by the Contractor to Safety, Welfare and Line Executive concerned.
- 5. A list containing the name of working person's photo, address, age, designation, nature of work is to be furnished immediately on receipt of the contract/work order. This is required for our records and issuance of Identity Card for Gate entry.

VI. GENERAL TERMS & CONDITIONS:

- **01. DEFINITION**: In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires:-
- (a) The **"Contract"** means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.
- (b) The "work" means, the work described in the tender documents in individual work-orders as may be issued from time to time to the contractor by the Officer-In charge within the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of contract.
- (c) The **"contractor"** means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
- (d) "The **Officer-In charge"** means, the Officer deputed by the, **Head of User Dept.** to supervise the work or part of the work.
- (e) "Approved" and "Directed" means, the approval or direction of Head of User Dept., or person deputed by him for the particular purposes.
- (f) BHARAT HEAVY ELECTRICALS LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other Administrative Officer of the said Company including **Sr. Manager / CONTRACTS / PPPU** authorized to invite tenders and enter into contract for works on behalf of the Company.
- (g) The **"Contract sum"** means, the sum accepted or the sum calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of the work during the currency of the contract.
