- 1 The prospective bidders who have downloaded the tender documents from our website are requested to send their acknowledgement and willingness to participate in the tender to the undersigned, through fax or email.
- 2 Offers should be strictly in accordance with the Tender Specifications and General Instructions to Tenderer enclosed herewith.
- 3 Clarifications, if any, can be obtained from the undersigned but such requests should be submitted well before the due date for submission of tenders. Due date for submission and opening of tenders will not be extended on such grounds.
- 4 Certain clauses of the "Conditions of contract for ETC works" have been modified in "Annexure to conditions of contract for ETC works" enclosed with the NIT. Wherever there is a deviation the clauses mentioned in the "Annexure to conditions of contract for ETC works" shall supersede the clause specified in "Conditions of Contract for ETC works"
- 5 Receipt of material/equipment, unloading, inspection, verification, storage & up-keeping during storage is deleted from the scope of bidders therefore, the clauses pertaining to these activities in the "Conditions of contract for ETC works" should not be referred to. However, transportation of equipment/material from stores/ switchyard area to erection site, reconciliation and shifting of all the balance excess material and scrap material to BHEL store or handover in customer store, as the case may be, is in the scope of bidders.**
- 6 Technical Bid will be opened in the office of undersigned. If required, technical discussions will be held with only those bidders who have taken any deviations. Bidders representative may be present during technical bid opening for technical discussion, if required. The price bids will be opened subsequently, after Technical Bids of all the Tenderers have been evaluated and finalized. Bidders should quote their most competitive rates as there will not be any price negotiation. However if felt necessary by BHEL, price negotiation will be held with lowest bidder (L-1) only. IT WOULD BE PREFERRED THAT YOUR OFFER IS WITHOUT ANY DEVIATION w.r.t. TENDER SPECIFICATIONS AND THE SAME MAY BE CLEARLY MENTIONED ON THE COVERING LETTER ACCOMPANYING THE TECHNICAL BID. Offers with deviations are likely to be rejected. However if the bidder insists on any technical or commercial deviations, from the specification and/or tender conditions, the price implication if any, of withdrawing the deviations must be submitted along with the price bid in a separate sealed envelope superscribed "Price Implication for withdrawal of deviations". No price implication for withdrawal of deviation shall be accepted at a later date, after the opening of technical bid.
- 7 Offer will be scrutinised based on the qualifying requirements mentioned in the NIT. However, final acceptance of the offers shall be subject to acceptance of our customer.
- 8 The purchase preference for central P.S.Us shall be given as per the prevailing Government policy.
- 9 The Bidders are advised to visit Site to have better understanding of job.
- 10 In case an offer is not being submitted by the prospective bidders against this tender, they may send their "regret" letter to this office, for information.
