3. Project Background & Objective

BHEL, intends to engage a service provider for Design, development, implementation. hosting & maintenance of Web-based portal for "Technology Innovation Platform". This portal will facilitate to kick start the speedy Problem solving, innovation and development of manufacturing technologies in India. It will create an open Technology Platform to aggregate talent and ideas in order to find solutions to India's technology gaps.

It is proposed to bring Industries, reputed research organizations, Academic Institute like IITs, NITs, Testing agencies and expert various fields on to one common platform. This match making process talent pool shall be self-driven to hasten solutions by creating an opportunity for innovation in the perpetual development and innovation process.

This technology platform broadly envisages:

a) To bring together young professionals, experienced individual experts, Academicians, Industries including MSME manufactures on a single platform to solve the current technology challenges being faced by domestic producers or any party that would like to get a technology solution. The Platform shall thus aggregate problems to be solved and allow young thinking minds to come together to offer solutions. The expert resources shall be available to be tapped by the young engineers/professionals as Mentors, if they so require.



- b) To facilitate collection of problems and throwing up solution providers based on interest and expertise.

In case of Reverse auction, BHEL will inform all qualified Bidders about Reverse Auction & the multiplication factor applicable to that bidder in order to arrive at destination cost or Cost to BHEL. The successful bid in the reverse auction will be the one with lowest destination cost or cost to BHEL. BHEL reserves the right to negotiate with the lowest bidder.

Bidder shall provide a period of 4 weeks bug free support after the website gets LIVE and needs to take care of any bugs or issues caused during this duration.

5.2 Training & User Manual preparation

Bidder shall prepare and provide comprehensive User Manual along with e-Module for Website functionalities and operation. On-line trainings, as required by BHEL, shall be arranged by Bidder.

5.3 Data Migration & Integration

BHEL has a similar in-house developed portal in use. The relevant data as identified & provided by BHEL shall be imported one-time by the successful Bidder to the portal.

5.4 Security Audit

Bidder shall undertake Security Audit of the solution prior to Go-Live / launch of the Portal.

Bidder shall ensure that development of the website is as per the Govt. of India or its agencies issued guidelines from time to time.

* Any corrective & preventive actions arising out of Security audits conducted by BHEL, Govt. agencies etc. shall be undertaken by the Bidder.

5.5 Hardware & Hosting

Bidder shall host/deploy the solution at a Government of India empaneled Cloud / Hosting Service Provider (MeitY empaneled Cloud Service Providers i.e. CSPs).

Bidder shall provide support on 24x7x365 basis for the Solution for the entire period of contract.

Service Level Agreement (SLA):

Minimum Uptime for Solution is 99.5% (per quarter)

Availability of service shall be assessed by the following formula:



Uptime = 100*(1-Total outage duration / Maximum available time)

* All times in Minutes

Maximum Available Time = No. of days in a quarter * 24 * 60 – (Scheduled Maintenance Time +BHEL introduced Outage)

Note: Scheduled Maintenance Time should not be more than one hour per month and BHEL should be informed at least 24 hours in advance and subsequent approval / acceptance should be taken from BHEL.

5.6 Support & Maintenance

Support & Maintenance shall commence upon completion of 4 weeks bug free support period of the project (as mentioned in Section 5.1).

Support & Maintenance Services to be provided are as below:

- i. The bidder will provide support services encompassing all the components of the project as specified elsewhere in this scope of work.
- ii. Support and Maintenance services provided, should assure round the clock availability of the system and associated Hardware, Software, Operating System, Database, User Interface, front end, back end and other software applications. The bidder would provide services on 24x7x365 days and shall have arrangement for them so as to ensure 99.5% availability of the Portal.

Preventive Maintenance - The bidder would have to perform the following activities for preventive maintenance of the entire setup during the Support and Maintenance period. Major activities covered are:

- Pro-active Risk Assessment.
- Health Monitoring of the overall system.
- Monitoring Application Event Log for Errors/Warnings and take corrective action
- Performance tuning and database administration
- Updating security patches and virus definitions etc. for entire setup
- Repair of registry, checking and removal of virus & malware, removal of remnants of viruses/worms/malwares

Server/VMs Management:

The bidder would have to perform the following activities necessary to keep the servers performing at optimum levels:

- System Administration
- Database Administration & Maintenance
- Monitoring of servers and troubleshooting. Resolving system hangs, hard disk crash etc and keeping a log of the same.
- Re-installation of OS and other software, if required.
- Package Management: Installation of package upgrades as and when provided by OEM and Un-installation and maintenance of packages, as and when required.
- Downloading of upgrades, bug fixes, updates of OS and other software etc.
- Network Troubleshooting, time synchronization, TCP/IP Management and ensuring portal access across the Organizations.
- Managing users and authentication parameters.



- Performance monitoring and log records.
- CPU, memory, disk space utilization, average load, network traffic monitoring etc.

Backup and Recovery

It will cover various servers/VMs with OS deployed under this project:

- Perform backup operation for the servers, as per defined Backup Strategy/Schedule, as mutually agreed between BHEL Team & the bidder based on system requirement.
- Secure storage and handling of media to prevent data loss.
- Maintain log sheets of backups taken.

Security Management

- Integration of authentication with associated database.

Application Services & Helpdesk Management

- Ensure access to the Portal, hosted on servers under the scope of this contract, through Internet.
- Ensure minimum 99% System Availability
- Forcibly terminating all open but inactive connections.
- Session control based on the user activities.
- Performance tuning of Portal deployed for optimum results.
- Ensure hassle free integration of web services and applications with the associated database for contents management and storage.
- Ensuring that the Portal can handle multimedia files (Video/Audio).
- Managing user and admin accounts and maintaining log of activities.
- Establish a 24x7x365 helpdesk and ticketing system to provide prompt support service for calls and bugs. Helpdesk shall be based in India in order to facilitate smooth operation of the portal.
- Bidder shall also have a monitoring tool for the no. of tickets raised, acknowledged and resolved for solution. The access of same should also be with BHEL to monitor the SLA for solution
- Bidder shall provide Portal, IVRS and Phone facility to attend and resolve the tickets.
 In case of phone call, bidder shall ensure that if a call is received is by Helpdesk and Helpdesk is busy attending another call then call should be automatically diverted to IVRS and then IVRS shall give an automated response that Helpdesk is busy and shall attend shortly.
- Response time to attend the call/tickets shall be 30 minutes and Resolution time shall be 4 hours from the time of the call logged. In case the call is escalated to OEM/third party resolution period shall be 24 hours from the time of the call logged.

Other services during Support and Maintenance



The bidder has to provide following other services:

- The Support and maintenance services will comprise of Preventive and Corrective maintenance of the software supplied. After doing corrective maintenance bidder's representative will submit a service call report
- The bidder will deploy and arrange requisite qualified manpower at their end to undertake all activities prescribed under Support and Maintenance scope of work. If required, Bidder will also plan and arrange requisite site visits of their persons without any extra cost to BHEL.
- The bidder will provide all details of their office/customer support office like telephone, fax, letter address, email, web site etc for communication to BHEL.
- All cost related to the preventive and corrective maintenance, shall be borne by the bidder during the currency of Support and Maintenance period

Payment for Milestone Sl. No. 1, as above, shall be made only upon submission of Performance Bank Guarantee (PBG) of equal amount. PBG shall be released to the Bidder upon commencement of Support & Maintenance phase (18 Weeks from contract commencement date).

7. Special Terms and Conditions

7.1 Rates

Rates are to be quoted as per Price Bid Format. Details of prevailing rates of taxes should be indicated separately. Bidders, in their own interest, are requested to check up and indicate the different tax tariff like service tax etc. Taxes not mentioned by the bidder in their bid will not be entertained at later date. However, during the execution of the contract any increase or decrease in the above taxes/imposition of new taxes will be entertained on submission of relevant documentary proof.

7.2 Taxes & Duties

- Taxes (GST) shall be extra and payable as per prevailing rates. Any change in applicable
 taxes or imposition of any new applicable tax by GOI, the same shall be borne by BHEL
 on submission of documentary proof by the vendor. However, any decrease in applicable
 taxes or any new tax, benefit shall be passed on to BHEL.
- Bill prepared by the contractor should be pre-numbered and must contain inter-alia GST registration number, PAN number and GST category (as per Good & service tax act).
- TAX deduction at source: Tax shall be deducted at source from running bill as per applicable income tax rule & other statutory requirements.
- BHEL will claim Input Tax credit on GST.
- Contractor to ensure compliance of GST law and rules applicable on supply involved in this tender and in the event of any non-compliance by contractor, implication of the same if any shall be an account of contractor.

7.3 Payment Terms

BHEL will make the payment within 45 days from the date of submission of invoice as per Payment Schedule.

7.4 Income Tax Depreciation

Income tax depreciation will be claimed by BHEL.

7.5 Sub-Contracting

Order / contract or any part thereof shall not be sub-contracted, assigned or otherwise transferred to any third party without prior written consent of BHEL.



7.6 Contract Review & Extension

Subject to satisfactory performance of the Vendor, as reviewed by BHEL towards the end of 3 (Three) Years period i.e. 12 Quarters of Hosting, Support & Maintenance, BHEL shall reserve the right to extend the contract for an additional period upto 2 (Two) Years (i.e. 8 Quarters of Hosting, Support & Maintenance) on same terms & conditions, and rates not exceeding the annual recurring charges.

7.7 Copyrights and Trade Marks

The source code, text, design, trademarks, photos and graphics in editable mode, or other artwork furnished in designing of the portal shall be owned by BHEL upon completion of the successful implementation by bidder. Complete documentation, source code of the website has to be provided as it should be copyright to BHEL.

7.8 Penalties

7.8.1 For late Delivery

If the Bidder fails to complete the milestone "Portal Configuration/Development completion Testing (incl. Security Testing) & Go-Live" (within 12 weeks of Contract commencement date) as per Sl. No. 3 in Section 6 Payment schedule, deliverables & timelines, BHEL will impose Liquidated Damage/Penalty at the rate of 0.5% of the total cost of Design, Development, Configuration & implementation, per week of delay or part thereof subject to a maximum of 10% of the total cost of Design, Development, Configuration & implementation. For this purpose, the period of delay shall be the delay attributable to the Bidder for the completion of work as per contract.

7.8.2 For SLA (Hosting & Maintenance related) non-conformance

Solution availability (SLA Compliance) will be reviewed quarterly and penalties for non-compliance will be deducted on quarterly basis from the Application Support & Maintenance charges. The penalty will be calculated as per the following formula:

8. General Terms and Conditions

8.1 Ethical Standard

Bidders are expected to observe the highest standard of ethics during the execution of this Contract. In pursuit of this policy, the Purchaser will reject a proposal for award if it finds out that the Bidder being considered for award has engaged in corrupt or fraudulent practices in competing for the Contract. For the purposes of this provision, the terms set forth below are defined as follows:

a) "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action in the procurement process or in Contract execution; and



b) "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process including collusive practices designed to establish bid prices at artificial, non-competitive levels to deprive the Purchaser of the benefits of competition;

By signing the Bid Forwarding Letter, the Bidder represents that for the software it supplies, it is the owner of the Intellectual Property Rights in the software. Willful misrepresentation of these facts shall be considered a fraudulent practice without prejudice to other remedies that the Purchaser may take.

8.2 Cost of Bidding

The Bidder shall bear all costs associated with the preparation and submission of its bid and the Purchaser will in no case be responsible or liable for those costs.

8.3 Procedure for Submission & Opening of Bids

Bids shall be accepted by the official inviting the tenders, in two parts, as described below, on or before the due date & time indicated in the Tender Notice.

Part-I: EMD & Techno-Commercial Bid

This part shall consist of the following:

Any other taxes, duties, levies and charges assessed on the bidder by local, national or any statutory authorities will not be payable by BHEL.

Price Bid should not contain any technical details and/or Commercial Terms & Conditions as the same are supposed to be contained in PART-I only, so that the same can be evaluated before opening of Price Bid(s).

- **8.5.2** Bids can also be delivered in person to the official inviting Bids.
- **8.5.3** Bids submitted by post shall be sent by "REGISTERED POST" only and shall be posted with due allowance for any postal delay. Bids shall be submitted latest by 1600 Hrs. of the due date. Bids received after the Due Date and Time of submission will be summarily rejected.

8.6 Bid Opening

- **8.6.1** PART-I (EMD & Techno-commercial Bid) may be opened on the due date and time as specified in the Enquiry Letter, in the presence of bidders who may like to attend. Part-II (Price Bid) shall be opened subsequently. However, Purchaser reserves the right to open both the parts simultaneously i.e. Part-I and Part-II together.
- **8.6.2** In case of public opening, date and time of Price Bid (Part-II) opening shall be intimated to the technically and commercially acceptable bidders only.
- **8.6.3** Purchaser also reserves the right to open the earlier i.e. superseded price bids, if any, submitted by the bidder(s), if required.
- **8.6.4** Not more than two representatives from each bidder will be permitted to be present during tender opening.
- **8.6.5** No correspondence shall be entertained from the bidders after the opening of Price Bid(s).
- **8.6.6** Standard pre-printed conditions of the bidders attached to the offer will not be accepted and only those mentioned in the body of his offer will be considered.
- **8.6.7** Unsolicited bids shall not be entertained. Unsolicited revised Price Bids also, shall not be entertained at any stage of the tendering process and will lead to automatic disqualification of the party's bid.



- **8.6.8** No Literature, Pamphlets other than what is specified is to be enclosed. All such enclosures shall be considered as unread and also will not be considered as part of the quotation.
- 8.6.9 Manufacturer's name, trade Mark or Patent No., if any, should be specified.
- **8.6.10** Purchaser reserves the right to negotiate the tender, if required.

8.7 Late Bids

Any proposal received by BHEL after the deadline for submission of bids shall be summarily rejected and returned unopened to the bidder.

8.8 Validity of Offer

Offer shall be kept valid for four months from the due date of Tender, for Purchaser acceptance

8.9 Deviations

Bids shall be submitted strictly in accordance with the requirements and terms & conditions of the Tender Enquiry. Bidders have to submit a "No Deviation Certificate" in Part-I of the offer as per Annexure-I.

8.10 Language of Bid

- **8.10.1** The bidder shall quote the rates in Hindi/English language and international numerals only. The metric system of units shall be used, for the purpose of tender.
- **8.10.2** Bidder shall fill the tender documents as per formats enclosed in this tender enquiry. All entries and signatures in the bid shall be in **BLUE/BLACK INK** only. Each page of the bid shall be signed and stamped using official seal of the company by the bidder.
- **8.10.3** All entries shall be filled in neat and legible handwriting. No over-writings, erasures and corrections are permitted and may render such bids liable for rejection.
- **8.10.4** However, if any cancellations, corrections and insertions are in the bid, the same shall be duly attested by the bidder.

8.11 Clarification on Bidding Documents

The Bidder is expected to carefully go through this Tender Document and understand the functional requirements thoroughly before submitting their offer. All legitimate queries and clarifications regarding this tender must be submitted in email to the ajay.bagati@bhel.in, gaurav.saxena@bhel.in

8.12 Amendment of Bidding Documents

The Purchaser may at its sole discretion amend the Bidding Documents at any time prior to the deadline for submission of bids. However, in case of such amendment, the bid submission date may be extended at the discretion of the purchaser.

Amendments made prior to submission of bid will be provided in the form of Addenda / Corrigendum to the Bidding Documents and will be posted on the BHEL website (www.bhel.com or http://eprocure.gov.in) in Tender Notification section.

8.13 Documents Accompanying the Bid

All documents shall be submitted as per the NIT. All documentary evidence in support of claims must clearly be marked as to against which criteria the document is submitted and should be fully indexed.

8.14 Tender Evaluation

- **8.14.1** Totals/Gross Total of Prices should be indicated both in words as well as in figures. If there is a difference between price quoted in words and figures or if there is any other price discrepancy, higher value(s) will be considered for evaluation and lower value will be considered for ordering.
- **8.14.2** All applicable taxes (VAT/Sales Tax, Service TAX) are to be specified clearly in the Price Bid Format.
- **8.14.3** After finalizing the techno-commercial offers, BHEL may adopt Reverse Auction process for arriving at the lowest price offer.
- **8.14.4** The Purchase Order will be placed on L1 vendor.

8.15 Security Deposit

Security Deposit means the security provided by the Contractor towards fulfilment of any obligations in terms of the provisions of the contract.

- **8.15.1** The service provider shall submit within 30 days of Order placement, an amount equal to 5% of the total contract value as security deposit in favor of "Bharat Heavy Electricals Limited" payable at New Delhi or Noida. EMD of the successful tenderer shall be converted and adjusted towards the required amount of Security Deposit.
- **8.15.2** At least 50% of the required Security Deposit, including the EMD, should be collected before start of the work. Balance of the Security Deposit can be collected by deducting 10% of the gross amount progressively from each of the running bills of the Contractor till the total amount of the required Security Deposit is collected.
- **8.15.3** If the value of work done at any time exceeds the contract value, the amount of Security Deposit shall be correspondingly enhanced and the additional Security Deposit shall be immediately deposited by the Contractor or recovered from payment/s due to the Contractor.
- **8.15.4** The recoveries made from running bills (cash deduction towards balance SD amount) can be released against submission of equivalent Bank Guarantee in acceptable form, but only once, before completion of work.

8.15.5 Modes of deposit

The balance amount to make up the required Security Deposit of 5% of the contract value may be accepted in the following forms:

- a. Cash (as permissible under the extant Income Tax Act)
- b. Local cheques of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favor of BHEL
- c. Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL
- d. Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
- e. Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL)



(Note: BHEL will not be liable or responsible in any manner for the collection of interest or renewal of the documents or in any other matter connected therewith)

- **8.15.6** Security Deposit shall be released to the Contractor upon fulfilment of contractual obligations as per terms of the contract.
- **8.15.7** The Security Deposit shall not carry any interest.
- **8.15.8** If the vendor does not submit Security Deposit on time, an amount equal to interest calculated, as per Prime Lending Rate of SBI plus 1 percent, will be charged from the vendor for the delayed period.
- **8.15.9** The validity of Bank Guarantees towards Security Deposit shall be initially up to the completion period as stipulated in the Letter of Intent/Award + 3 months, and the same shall be kept valid by proper renewal till the acceptance of Final Bills of the Contractor, by BHEL.
- **8.15.10** BHEL reserves the right of forfeiture of Security Deposit in addition to other claims and penalties in the event of the Contractor's failure to fulfil any of the contractual obligations or in the event of termination of contract as per terms and conditions of contract. BHEL reserves the right to set off the Security Deposit against any claims of other contracts with BHEL.

8.16 Return of Security Deposit

Security Deposit shall be refunded/Bank Guarantee(s) released to the Contractor after deducting all expenses / other amounts due to BHEL under the contract / other contracts entered into with them by BHEL.

8.17 Purchaser's Right to accept or Reject any or all Bids

The Purchaser reserves the right to make changes within the scope of the Contract at any point of time.

- **8.17.1** The Purchaser reserves the right to accept or reject any or all bids, and to annul the Tender process at any time prior to the issue of Letter of Award. In this case, the Purchaser shall not incur any liability to the affected Bidders or any obligation to inform the affected Bidders about reasons for such action.
- **8.17.2** The Bidder shall not sub-contract supply of software/licenses without written consent from BHEL. Further, BHEL shall not be liable for making any payments to the sub-bidders.

8.18 Statutory Obligations

All statutory obligations arising out of this contract (like Insurance, PF, etc. of man power deployed by the bidder) shall rest with the successful bidder.

8.19 Liabilities from the Contract

Any liabilities arising out of this contract (like injury, fatal/non-fatal, to the personnel of the successful bidder or any third party/contractor employed by the bidder) shall be to the successful bidder's account only. BHEL shall not be liable in any such eventuality.

8.20 Non-Disclosure Agreement

- **8.20.1** The successful bidder shall comply with the Information Security Management System of BHEL and work within the framework of ISMS as applicable in BHEL from time to time.
- **8.20.2** All the material / information sent to the successful bidder shall be treated as confidential and should not be disclosed in any matter to any unauthorized person under any circumstances. The successful bidder has to furnish a Non-Disclosure Agreement (NDA) as



per Annexure-III in line with the owner's Information Security Management System (ISMS).

8.21 Risk Purchase

BHEL reserves the right to purchase/hire from elsewhere at the risk and cost of the vendor, either the whole or part of

- a) The Systems/Goods/Service, which the vendor has failed to deliver within the stipulated delivery period in the concerned Purchase/Work Order or if the same were not available, the best and the nearest available substitute(s) thereof which is not technically inferior to the undelivered System/Goods/Service.
- b) The warranty and support which the vendor has failed to provide in respect of the supplied system/goods/service suffering from not less than 1 month of downtime.

The vendor shall compensate BHEL for any loss or additional expense, which BHEL may sustain by reason of such purchase. BHEL may recover the amount from any money due to the vendor in respect of this contract or any other contract which the Contractor has with BHEL. This clause will be operated only after completion of delivery period including extended period with LD, if any.

Recovery on account of purchases made by Purchaser/BHEL at the risk and cost of Seller/Contractor shall be worked out as follows:

Excess of new purchase cost over old purchase cost, where the total value of new PO is more than total value of old PO.

And

Additional 30% overheads as departmental charges on the ex-works value of new PO.

8.22 Arbitration

In all cases of disputes emanating from and in reference to this contract, the matter shall be referred to the arbitration. All disputes or differences between the parties will be resolved through arbitration governed by "The Arbitration and Conciliation Act, 1996" as amended from time to time. The venue of arbitration shall be in New Delhi. However, till the time the decision of the arbitrator is not announced, the Bidder/Vendor shall continue to provide its services to BHEL as per the contract.

8.23 Laws Governing the Contract

The order/ contract shall be executed and governed by the laws of India and the courts of India alone shall have jurisdiction in respect of any matter arising under or in connection with the order/ contract.

Courts at Delhi/ New Delhi shall have exclusive jurisdiction to decide the dispute, if any, arising out of or in respect of the contract to which these conditions are applicable.

8.24 Merger & Acquisition

In case of mergers and acquisitions of the bidder company or the OEM, all the contractual conditions and obligations shall automatically get transferred to acquiring company / entity and acquiring company must assume all the obligations of the contract till the end of the contract period.

8.25 Bankruptcy

If the Bidder becomes bankrupt or have a receiving order made against him or compound with his creditors or being a Corporation commence to be wound up, not being a voluntary winding up for



the purpose only or amalgamation or reconstruction, or carry on their business under a receiver for the benefit of their creditors or any of them, BHEL shall be at liberty:

- **8.25.1** To terminate the engagement forthwith without any notice in writing to the Bidder or to the liquidator or receiver or to any person in whom the Bidder may become vested.
- **8.25.2** To give such liquidator or receiver or other person the option of carrying out the engagement subject to their providing a guarantee for the due and faithful performance of the engagement up to an amount to be determined by BHEL.

8.26 Force Majeure

Vendor shall not be responsible for delay in delivery resulting from acts / events beyond his control, provided notice of the happening of any such act / event is given by the Vendor to the Purchaser within 15 days from the date of its occurrence. Such acts / events shall include but not be limited to acts of God, war, floods, earthquakes, strikes, lockouts, epidemics, riots, fire or Governmental regulations superimposed after the date of order / contract.

8.27 Indemnity

Vendor/Lessor shall fully indemnify and keep indemnified the Purchaser/Lessee against all claims which may be made in respect of the use of System / Software / Item(s) / services supplied / rendered by the Vendor / Lessor, for infringement of any rights protected by patent, registration of designs or trademarks and legality of the Software. All such claims in this regard will be settled as per Indian Laws.

In the event of any such claims being made against the Purchaser/Lessee, Purchaser/Lessee will inform in writing to the Vendor/Lessor who shall at his own risk and cost either settle any such dispute or conduct any litigation that may arise there from.

8.28 Limitation of Liability

The vendor's liability shall be limited to the value of this contract only.

- 1. When informed of the proprietary and confidential nature of Confidential Information that has been disclosed by the other Party, the receiving Party ("Recipient") shall, for a period of three (3) years from the date of disclosure, refrain from disclosing such Confidential Information to any contractor or other third party without prior, written approval from the disclosing Party and shall protect such Confidential Information from inadvertent disclosure to a third party using the same care and diligence that the Recipient uses to protect its own proprietary and confidential information, but in no case less than reasonable care.  - 5.2. Is or becomes publicly known through no wrongful act of the Recipient, its employees, officers, directors, or agents; or
 - 5.3. Is independently developed by the Recipient without reference to any Confidential Information disclosed hereunder; or
 - 5.4. Is approved for release (and only to the extent so approved) by the disclosing Party; or
 - 5.5. Is disclosed pursuant to the lawful requirement of a court or governmental agency or where required by operation of law.

BHEL has made arrangement with M/s e-Procurement Technologies Limited, who shall be BHEL's authorized service provider for the same. Bidders should go through the instructions given below and submit acceptance of the same.

The technical & commercial terms are as per (a) BHEL Tender Enq. No. AA:CDT:2020/TIP, dated 04.08.2020, (b) Bidders' technical & commercial bid (in case of two part bid) and (c) subsequent correspondences between BHEL and the bidders, if any.

1. Procedure of Reverse Auctioning

- i. Price bids of all techno-commercially qualified bidders shall be opened.
- ii. Online Reverse Auction: The 'bid decrement' will be decided by BHEL.
- iii. If BHEL decides the lowest sealed envelope price bid as the starting price, then the lowest bidder in sealed envelope price bid shall be shown as current L1 automatically by the system and no acceptance of that price is required. 12. Proxy bids: Proxy bidding feature is a pro-bidder feature to safe guard the bidder's interest of any internet failure or to avoid last minute rush. The proxy feature allows bidders to place an automated bid in the system directly in an auction and bid without having to enter a new amount each time a competing bidder submits a new offer. The bid amount that a bidder enters is the minimum that the bidder is willing to offer. Here the software bids on behalf of the bidder. This obviates the need for the bidder participating in the bidding process until the proxy bid amount is decrementally reached by other bidders. When proxy bid amount is reached, the bidder (who has submitted the proxy bid) has an option to start participating in the bidding process.

The proxy amount is the minimum amount that the bidder is willing to offer. During the course of bidding, the bidder cannot delete or change the amount of a proxy bid.

Bids are submitted in decrements (decreasing bid amounts). The application automates proxy bidding by processing proxy bids automatically, according to the decrement that the auction originator originally established when creating the auction, submitting offers to the next bid decrement each time a competing bidder bids, regardless of the fact whether the competing bids are submitted as proxy or standard bids.
