**DELIVERY:-** Delivery shall be within Six (06) months from the date of PO or Five (05) months from the date of CAT - 1 drawing approval/manufacturing clearance issued by BHEL/customer, whichever is later, subject to bidder shall submit the drawing/ doc within two weeks after the date of PO. Vendor to resubmit documents within 10 days only, taking care of all the comments of BHEL. BHEL shall approve/comment the same within 15 days of receipt from vendor. Any deficiency in documents submitted w.r.t agreed specification/comments from BHEL shall be treated as non-submission and no. of days delay in submission of complete documents the approval process, on account of this, would be reduced from the delivery. The vendor shall be responsible for getting approval from BHEL as early as possible and BHEL will support the process, in full, within above time frame. BHEL/ Customer shall approve the docs./ give manufacturing clearance within one month of receipt of drgs./ docs. from the vendor.

2. Offers should be submitted in two parts in two separate sealed covers as follows:

Part-II: **PRICE BID.**

3. Bidders shall submit their offers meeting the re quirements of the following tender documents (enclosed) and other Terms and Conditions of **GCC (REV 04)** included in this Enquiry Letter:

19. Vendors to note that along with the payment terms mentioned in our GCC Rev 04 following clause will also be applicable:-
