12. Definition of Terms is also enclosed. These definitions will apply to all the tender documents including this Enquiry Letter.

13. Delivery:-

"Six (06) months from drgs. /docs. approval in CAT-I issued by BHEL. This is subject to bidder's 1st submission of drawing/docs within two weeks from the date of P.O. Vendor to re-submit documents within 7 days only, taking care of all the comments of BHEL. BHEL shall approve/ comment on drgs./ docs. within 10 days. BHEL shall approve all drgs./ docs. in Cat-I in total 2 months time from the date of P.O. inline with the above drg/doc submission schedule by BHEL & vendor. Any deficiency in documents submitted w.r.t. agreed specification/ comments from BHEL shall be treated as non-submission and no. of days delay in submission of complete documents during approval process, on account of this, would be reduced from the delivery. The vendor shall be responsible for getting approval from BHEL as early as possible and BHEL will support the process, in full, within above time frame and terms & conditions."

14. **PRE-QUALIFICATION REQUIREMENT:-**

Bidders are requested to fill up the details in **"TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENT"** and also to submit the credentials. The bidders, who are already registered with BHEL PEM for the tendered package *without any technical/financial limit*, need not submit the Technical/ Financial PQR. They will be considered qualified on Technical/ Financial PQR based on their registration with BHEL PEM. Technically PQR shall be evaluated for Non registered vendors and PEM registered vendors with technical limit falling outside project scope.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements. Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid of only BHEL and customer approved vendors shall be opened and same shall be covered in NIT.

15. Evaluation criteria for this package shall be item wise evaluation. Since item wise evaluation will be done, we propose opening of hard Price Bids of the bidders and not to conduct Reverse Auction for this tender.
