Standard Terms & Conditions

1. Quotations Format:

Offer should mention Enquiry No, Enquiry SL. No, Material Code Item Description, Unit, Quantity, Unit Price on FOR Goindwal Sahib basis, all taxes and duties rates, extra/inclusive, Delivery schedule, Validity of Offers. Please note that no separate discount should be mentioned. Only final & Firm price should be given. Prices should remain firm till order execution.

2. Access to manufacturing premises:

While Purchase Orders placed on the vendor are under execution, authorized representatives of BHEL shall be allowed free access to the manufacturing facilities for the purpose of inspection or monitoring the progress of purchase orders. This access will also be extended to representatives of BHEL's customers accompanying the authorized representative/s of BHEL, if our contractual requirements with our customers call for the samé.

3. Terms of Payment:

100% payment against supplies received shall be made within 30 –45 days of receipt and inspection clearance of material at IVP Goindwal. Commercial invoice (In duplicate)

Excise invoice (in duplicate) valid for claiming CENVAT credit Original VAT invoice valid for claiming input tax credit, if applicable

All required Test Certificates and Guarantee Certificate.

Above documents should include your Registration numbers such as ECC no, PAN No, CST no, TIN/ VAT nos. etc.

BHEL releases payment through EFT mode ONLY. Vendors, on whom, finally POs are released may please provide the necessary details by obtaining format before release of payment, if already not submitted.

4. Liquidated damages:

It is clearly understood among the parties to the contract the "Time is the essence of the contract". Therefore, the delivery of the goods specified in the purchase order should be made within the time prescribed. Failure to dispatch the materials in the time as per the delivery quoted in our Purchase Order would make the supplier liable to an unconditional penalty at the rate of 1/2% of the value of goods for each week of delay subject to a maximum of 5% of the order value.

5. Risk purchase:

If the supplier fails to deliver the goods within the delivery specified in the Purchase Order, BHEL will be entitled to terminate the contract and to purchase elsewhere at the risk and cost of the seller either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the delivery period mentioned in the Purchase Order.

6. Inspection & Testing:

All goods shall be subject to inspection by BHEL or its authorized representatives at supplier's works or at BHEL stores. The supplier will not charge for the facilities provided for inspection of goods. Final inspection and acceptance of the machine will be carried out after utilization of the tool at BHEL. Goindwal.

7. Subcontract:

The purchase order or any part thereof shall not be sub-contracted, assigned or otherwise transferred without previously obtaining the BHEL's consent in writing.

8. Force Majeure:

If at any time during the execution of the order, the performance in which or in any part by either party of any obligations under the contract are prevented or delayed by reason of any war, hostilities, acts of public enemy, civil commotion, sabotage, fires, explosions, epidemics, quarantine restrictions, or acts of God (hereinafter referred to "an events" then provided the notice of happening of any such event is given by either party to the other within 21 days of the occurrence thereof, neither party shall by reason of such event be entitled to terminate the contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance and delivery under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under the contract is prevented or delayed by reason of any such event, claims of extension of time shall be granted for periods considered reasonable by BHEL subject to prior notification by the vendor to BHEL of the particulars of the event and supply to BHEL, if required, of any supporting evidence. Any waiver of time in respect of partial installment shall not be deemed a waiver of time in respect of remaining deliveries.

9. Disputes:

In the event of any dispute and/or difference arising between the Vendor and BHEL as to interpretation and/or execution of the contract and/or the respective rights and liabilities of the parties, such disputes and/or differences shall be referred to the sole arbitrator nominated by BHEL. The provisions of the Indian Arbitration Act and the rules there under shall apply to such arbitration. The award passed by the arbitrator shall be final and conclusively binding on all the parties.

10. Jurisdiction:

The court of the place from where the purchase order is issued or is under execution during the contractual period shall alone have jurisdiction to decide any dispute arising out of or in connection with the purchase order.

11. General:

Evaluation of offers shall be on the basis of landed cost to BHEL after taking all factors affecting price of the item.

BHEL reserve the right to give price preference to Public Sector Enterprises admissible under the existing policy.

BHEL reserves the right to reject any tender due to unsatisfactory past performance in the execution of a contract at another project /BHEL unit even if BHEL comes to know after placement of PO.

BHEL reserves the right to reject or accept any tender, part or in full, at their own discretion without assigning any reason thereof. BHEL reserves the right to negotiate with L1, if the offer prices are abnormally deviating from estimates.
