SCOPE OF WORK & TECHNICAL SPECIFICATIONS

1. Overview: Appointment of Secretarial and Corporate Governance Auditor

Pursuant to applicable provisions of Companies Act, 2013 read with the Rules as well as the Securities & Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), BHEL is required to undertake secretarial audit and to annex a secretarial audit report given by a company secretary in practice, in such form as specified, with its Board's Report. Further, as per the SEBI Listing Regulations, BHEL is required to submit a secretarial compliance report in such form as specified, to the stock exchanges, within sixty days from end of each financial year. In addition, as per the provisions of the SEBI Listing Regulations and the Guidelines on Corporate Governance for CPSEs issued by the Department of Public Enterprises, vide Office Memorandum No. 18(8)/2005-GM dated 14.05.2010, BHEL is required to obtain a certificate regarding compliance of conditions of corporate governance and annex the certificate with the Directors' Report. Accordingly, BHEL wishes to engage a Practising Company Secretary (PCS)/ PCS Firm as an Auditor to undertake Secretarial & Corporate Governance Audit of BHEL and issue reports/ certificates in that respect for the Financial Years 2021-22 and 2022-23.

2. Scope of Work

The PCS/ PCS Firm appointed as an Auditor shall be required to undertake the following for the Financial Years (FYs) 2021-22 and 2022-23: -

- Secretarial Audit of BHEL as per the requirements of Companies Act, 2013, rules made thereunder and SEBI Listing Regulations as well as any notifications/ circulars/ clarifications issued by the Ministry of Corporate Affairs (MCA)/ SEBI and timely issue of Secretarial Audit Report inline with the provisions contained therein.
- Issue Secretarial Compliance Report as per the requirements of SEBI Listing Regulations and notifications/ circulars/ clarifications issued by SEBI.
- Audit of the conditions of corporate governance under the SEBI Listing Regulations and DPE Guidelines on Corporate Governance for CPSEs and issue Certificate on Corporate Governance inline with the provisions contained therein.

3. Date & Schedule of Secretarial and Corporate Governance Audit

The schedule of undertaking of the audits and issuance of the Secretarial Audit Report, Secretarial Compliance Report and Certificate on Corporate Governance shall be confirmed based on the legal requirements including finalisation of the date of BHEL's Annual General meeting for the said years (tentatively to be held by the end of September in succeeding years) under review i.e. FY 2021-22 and FY 2022-23.

4. Related Services pursuant to amendment of Statutory Provisions

The PCS/ PCS Firm shall provide any additional information/ documents/ reports/ certificates, if any, further required (after allotment of work through this tender) under provisions of Companies Act, 2013, rules made thereunder, SEBI Listing Regulations and circulars/ clarifications/ notifications issued by MCA/ SEBI Secretarial Standards issued by the Institute of Company Secretaries of India (ICSI) and any other applicable laws with regard to Secretarial and Corporate Governance Audits in BHEL to ensure complete compliance as per statutory requirements.





Annexure II

PRE-QUALIFYING REQUIREMENTS (PQR)

Offers shall be considered only from technically competent and experienced PCS/ PCS Firm as per the following Pre-Qualifying Requirements (PQR):

(1) PEER REVIEW

The PCS/ PCS Firm has to submit a copy of valid Peer Review Certificate issued by ICSI.

(2) OFFICE

The PCS/ PCS Firm should have a Service Centre or a Representative office in Delhi-National Capital Territory.

(3) WORK EXPERIENCE

The PCS/ PCS Firm should have the following prior experience:

- a) A minimum of 5 years of experience after receiving of membership from Institute of Company Secretaries of India and
- b) During the last 5 years (i.e. w.e.f. FY 2015-16), issued in any one or more than one Maharatna/ Navratna Companies, at least
 - (i) Two Secretarial Audit Reports or
 - (ii) Two Corporate Governance Report or
 - (iii) One Secretarial Audit Report and One Corporate Governance Report

(4) NO DEVIATION CERTIFICATE – Annexure V

- a) The PCS/ PCS Firm should accept all terms & conditions of the tender unconditionally. In case, any PCS/ PCS Firm wants to deviate from the tender conditions, such deviations shall be clearly specified in **No Deviation Certificate – Annexure V**. If no deviation is given in tender submitted, it will be assumed that the bidder accepts all terms and conditions of the tender.
- b) Deviations may or may not be accepted by BHEL. Any deviation accepted by BHEL for a PCS/ PCS Firm may be extended to all bidders.
- c) In case a deviation is not accepted by BHEL, the PCS/ PCS Firm is required to withdraw the same, otherwise its bid is liable to be rejected and in such case no bidder shall have any claim arising out of such action. BHEL's decision on the same shall be final and binding.

(5) SELF DECLARATION CERTIFICATE – Annexure VI

The bidder has to submit a **Self-Declaration Certificate** as per **Annexure VI**, certifying that Secretarial and Corporate Governance Audit services being offered to BHEL complies with the provisions of Companies Act 2013, rules made thereunder, SEBI Listing Regulations and circulars/ clarifications/ notifications issued by MCA/ SEBI, Secretarial standards issued by ICSI, any other law/ rule/ requirement pertaining to Secretarial and Corporate Governance Audit and associated activities including any amendment therein.





GENERAL TERMS AND CONDITIONS

1. INSTRUCTIONS FOR THE BIDDERS

- a) The offer shall be submitted as per the instructions of tender document. Only one set of tender document duly signed & stamped on each page shall be submitted by hand/courier as detailed. Bidder should note specifically that all pages of tender document shall be submitted by them (after signing/ stamping on each page) as a token of acceptance of the terms & conditions.
- b) Price shall not be mentioned anywhere, except in the Price Bid (**Annexure-VIII**).
- c) The bidders are advised to obtain all the necessary information related to the scope of work/ specifications before submitting their offers. Any queries regarding this tender may be clarified from the Dy. Manager (Company Secretariat) on landline no. 011-66337506 or e-mail: miriam@bhel.in.
- d) All the tender documents including Corrigendum/ Addendum shall be uploaded on BHEL web site (www.bhel.com), CPP Portal (<http://eprocure.gov.in/cppp/>) and ICSI website (<https://www.icsi.edu>) which can be downloaded and used as tender document for submitting the bid.
- e) No overwriting/ correction in tender documents by bidder shall be allowed. However, if correction is unavoidable, the same must be counter-signed & stamped.
- f) BHEL reserves the right to accept or reject any or all offers without assigning any reason thereof. Also, BHEL shall not entertain any correspondence from bidders in this matter.
- g) Only the Techno-Commercial Bids received from bidders till the deadline shall be opened on 30.12.2021 at 1430 Hrs. The bidders or their representative may attend the opening of the techno-commercial bids, if they so desire.
- h) Bidders are required to quote for the complete scope of work. Tenders for part of the work or incomplete in any respect are liable to be rejected.

2. VALIDITY OF BID/RATES: The bids/rates received shall be valid till **31st March, 2022**.

3. EVALUTION CRITERIA & AWARD OF WORK:

The Techno-commercial bids received till the last date & time for submission shall be scrutinized & evaluated as per the PQR and terms & conditions of the tender enquiry. Clarifications shall be sought from bidders if required and bidders shall be permitted to submit their documents/ clarifications by a cut-off date.

Price Bids of only techno-commercially qualified bidders shall be opened at later stage which shall be intimated to them through e-mail. The price bids shall be evaluated based on the total amount quoted (all-inclusive excluding GST) in Price Performa. The award of work/ work order shall be placed on the L-1 bidder subject to suitability of offer & reasonability of rates and solely at discretion of BHEL.

In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders. In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by

a toss/draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s). Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.

4. QUALITY STANDARDS:

All services shall conform to the scope of work/ technical specifications and statutory requirements as per SEBI/MCA or else liable for penalty/rejection at no costs thereon. The service provider shall deploy only skilful & technically sound staff/ manpower w.r.t. services being offered to the satisfaction of BHEL.

5. LIQUIDATED DAMAGES – QUALITY

If the provided service does not match the quality and specifications mentioned, BHEL will not be obliged to accept the particular service(s) as applicable. If at all it is accepted, LD shall be imposed at a rate to be decided by BHEL.

6. PROVISIONS FOR MICRO AND SMALL ENTERPRISES (MSEs)

Any Bidder falling under MSE category, shall furnish the following details & submit documentary evidence/ Govt. Certificate etc., in support of the same along with their offer.

Note: - If the bidder does not furnish the above, offer shall be processed construing that the bidder is not falling under MSE category.

- (i) MSE suppliers / bidders can avail the intended benefits only if they submit along with the offer, attested copies of either Udyam, Udyog Aadhaar or EM-II certificate having deemed validity (five years from the date of issue of acknowledgement in EM-II) or valid NSIC certificate or EM-II certificate along with attested copy of a CA certificate where deemed validity of EM-II certificate of five years has expired applicable for the last audited financial year. Date to be reckoned for determining the deemed validity will be the last date of Bid submission. Non submission of such documents will lead to consideration of their bids at par with other bidders. No benefits shall be applicable for this enquiry if the above required documents are not submitted along with offer.
- (ii) In case of any change in the MSE status of the Bidder, it shall be the responsibility of the Bidder to notify the change as a part of the Bid document. If at a later date, it comes to the knowledge of BHEL that the change in the status has not been intimated by the Bidder and the order is obtained under the premise of an MSE then BHEL would cancel the pending order against this tender and take necessary steps for suspension of the business dealing with the Bidder as per the procurement policy of BHEL.
- (iii) However, credentials of all MSE suppliers / bidders will be verified before considering the intended benefits for MSE suppliers at the time of tender evaluation.





- (iv) Start-ups who are also registered as MSEs and wish to avail the benefits as applicable to MSE, shall submit relevant documents covered under Conditions for Micro and Small Enterprises elsewhere in this tender.
- (v) MSE bidders will get the intended benefits as per the Public Procurement Policy 2012 for MSE & its Amendment(s) thereafter.

7. REJECTION OF BIDS

- a) BHEL reserves the right to accept or reject any of the bid/all bids with or without deviation or cancel/withdraw the invitation for bid without assigning any reason whatsoever and in such case bidder shall have no claim arising out of such action by BHEL. The acceptance of bid will rest with BHEL, not binding itself to accept the lowest tender.
- b) BHEL also reserves the right to cancel the tender at any stage due to any administrative / internal reasons; whatsoever and in such case bidder(s)/successful bidder shall have no claim arising out of such action by BHEL.
- c) Unsolicited bids, bids which are incomplete or not in the form specified or defective or have been materially altered or not in accordance with the tender conditions, specifications etc., are liable to be rejected.
- d) If a bidder who is a proprietor expires after the submission of his bid or after the acceptance of his bid, BHEL may at their discretion, cancel such a bid. If a partner of a firm expires after the submission of tender or after the acceptance of the tender, BHEL may then cancel such tender at their discretion, unless the firm retains its character.
- e) If the bidder deliberately gives wrong information in his bid, BHEL reserves the right to reject such bid at any stage or to cancel the contract if awarded and forfeit any money due under the contract.
- f) Canvassing in any form in connection with the bids submitted by the Bidder shall make the offer liable to rejection.
- g) In case the PCS/ Proprietor or Partner of the Firm submitting the tender, has any relative or relation employed in BHEL, the authority inviting the tender shall be informed of the fact along with the Offer. Failing to do so, BHEL may, at its sole discretion, may reject the tender or cancel the contract.
- h) The offers of the bidders who are under suspension and also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website www.bhel.com.

8. PRICE

- a) Price quoted should be firm during the entire duration of contract.
- b) Price quoted shall be all inclusive except GST (as applicable), which should be indicated separately in the column provided in the Price Bid enclosed as Annexure-VIII.
- c) Price to be filled-in strictly as per the Price Bid enclosed as Annexure-VIII. Change in Performance is not allowed.
- d) The bidders are required to quote essentially for the entire scope of work.
- e) Offers not fulfilling any of the above conditions are liable for rejection.

9. TAXES & DUTIES

- a) It is mandatory to comply with all taxes applicable for the required services. Your price should be all inclusive, except GST. The amount towards GST should be indicated separately in the specified place in Price Bid enclosed as Annexure- VIII.
- b) To enable BHEL to avail GST Input tax credit, party shall submit invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Such invoice shall be submitted within prescribed time limit in the name of BHEL Corporate Office, BHEL House, Siri Fort, New Delhi. Payment shall be made to the party only after submission of GST compliant tax invoice as mentioned above and other relevant documents.
- c) In case of any loss incurred by BHEL on account of non-compliance of GST laws by vendor/service provider, the same shall be charged to party's account and the same shall be withheld/recovered from party.
- d) Any statutory changes as and when made applicable by the Government shall become applicable against documentary evidence.
- e) Payment to the party will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act & GST, as amended from time to time and a certificate to this effect to be provided to party.
- f) Applicable GST shall also be recoverable from the contractor/ bidder in case of LD recovery/penalty on account of breach of terms of contract.

10. TERMS OF PAYMENT

- a) Payment shall be made to agency only after submission of GST compliant tax invoice as mentioned above and other relevant documents.
- b) GSTIN of BHEL will be provided to the agency along with the work order.
- c) Full payment shall be made within 30 days of satisfactory completion of the job and receipt of in-discrepant bill.
- d) While making the payment, statutory deductions as applicable, shall be made by BHEL. Payment to the agency will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act and GST as applicable, as amended from time to time and a certificate to this effect shall be provided to the agency by BHEL.
- e) BHEL reserves the right to make the payment through NEFT mode.
- f) No advance payment of work will be made to the agency.

11. ACCEPTANCE OF TERMS AND CONDITIONS

- a) The bidder should accept all terms & conditions of the tender unconditionally. In case the bidder wants to deviate from the tender conditions, such deviations shall be clearly specified in **No Deviation Certificate – Annexure V**. If no deviation is given in tender submitted, it will be assumed that the bidder accepts all terms and conditions of the tender.
- b) Deviations may or may not be accepted by BHEL. Any deviation accepted by BHEL for a bidder may be extended to all bidders.
- c) In case a deviation is not accepted by BHEL, the bidder is required to withdraw the same, otherwise its bid is liable to be rejected and in such case no bidder shall have any claim arising out of such action. BHEL's decision on the same shall be final and binding.





12. INCOMPLETE TENDERS

- a) Incomplete tenders, which do not contain all the information called for or bid not submitted as per terms & conditions, are liable to be rejected.
- b) The decision of BHEL in respect of evaluation of bids and/or award of contract shall be final.

13. CANCEL/SCRAP OF TENDER

BHEL also reserves the right to cancel/ scrap the tender at any stage without assigning any reason whatsoever.

14. ARBITRATION

- a) In the event of any dispute or difference arising out of the execution of the Order/ Contract or the respective rights and liabilities of the agencies or in relation to interpretation of any provision between BHEL & Service Provider in any manner touching upon the Order/Contract, such dispute or difference shall (except as to any matters, the decision of which is specifically provided for therein) be referred to the arbitration of the person appointed by the competent authority of BHEL.
- b) Subject as aforesaid, the provisions of Arbitration and Conciliation Act, 1996 (India) or statutory modifications or re-enactments thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause. The venue of arbitration shall be at New Delhi.
- c) In case of order/contract on Public Sector Enterprises (PSE) or a Govt. Deptt., the following clause shall be applicable: -

In the event of any dispute or difference relating to the interpretation and application of the provisions of the Order/Contract, such dispute or difference shall be referred to by either party to the arbitration of one of the arbitrators in the department of public enterprises. The award of the arbitrator shall be binding upon the agencies to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law secretary, Deptt. of Legal Affairs, Ministry of Law & Justice, Government of India. Upon such reference the dispute shall be decided by the Law Secretary or the Special Secretary or Additional Secretary when so authorized by the Law Secretary, whose decision shall bind the agencies hereto finally and conclusively. The agencies in the dispute will bear equally the cost of arbitration as intimated by the arbitrator.

15. LAWS GOVERNING THE CONTRACT

The Order/Contract shall be executed and governed by the laws of India and the courts of India alone shall have jurisdiction in respect of any matter arising under or in connection with the Order/Contract.

16. JURISDICTION OF COURT

Courts at Delhi/New Delhi shall have exclusive jurisdiction to decide the dispute, if any, arising out of or in respect of the contract(s) to which these conditions are applicable.

17. DEFAULT/ BREACH OF CONTRACT, INSOLVENCY AND RISK PURCHASE

- a) If the Service Provider / Agency fails to provide the required services as per the Contract delivers goods or materials not of the contracted quality and failing to adhere to the contract specifications or at any time repudiates or otherwise abandons the contract before expiry of such period or refuses or is unable to supply / provide goods / services or materials covered by the Order/Contract either in whole or in part or otherwise fails to perform the Order/Contract or commits any breach of the Order/Contract not herein specifically provided for or in the event of the death or insanity or if the Seller/Agency being an individual or if a firm on a partnership thereof, shall at any time, be adjudged insolvent or shall have a receiving order for administration of his estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any assignment of the Order/Contract or enter into any arrangement or composition with his creditors or suspend payment or if the firm dissolved under the Partnership Act or if the Seller/Agency (Service Provider) being a company is wound up voluntarily or by order of a Court or a Receiver, Liquidator or Manager on behalf of the debenture holders and creditors is appointed or circumstances shall have arisen which entitles the Court of debenture holder and creditors to appoint a receiver, liquidator or manager, the purchaser without prejudice to his right to recover any expenses, losses or damages to which the purchaser may be put to incur or sustain by reason of the Seller/Agency's default or breach of Order/Contract shall be entitled to cancel the Order/Contract either in whole or portion thereof without compensation to the Seller/Agency (Service Provider) and if the purchaser so desires, he may procure upon such terms and in such manner as he deems appropriate, stores not so delivered or others of a similar description where stores exactly complying with particulars are not, in the opinion of the purchaser, which shall be final, readily procurable, at the risk and cost of the Seller/Agency (Service Provider) and the Seller/Agency (Service Provider) shall be liable to the purchaser for any excess costs provided that the Seller/Agency (Service Provider) shall continue the performance of the Order/Contract to the extent not cancelled under the provisions of this clause. The Seller/Agency (Service Provider) shall on no account be entitled to any gain on such repurchases.
- b) Cost of the purchases/service made by the Purchaser/Service taker at the risk and cost of the seller/agency (Service Provider) shall be worked out after levying 30% overheads as departmental charges on the cost of materials / services so purchased/hired.

18. INTEGRITY COMMITMENT, PERFORMANCE OF THE CONTRACT

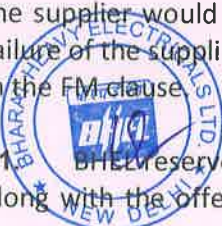
20. FORCE MAJEURE:

A Force Majeure (FM) means extraordinary events or circumstance beyond human control such as an event described as an Act of God (like a natural calamity) or events such as war, strike, riots, crimes (but not including negligence or wrong-doing, predictable/seasonal rain and any other events specifically excluded in the clause). An FM clause in the contract frees both parties from contractual liability or obligation when prevented by such events from fulfilling their obligations under the contract.

An FM clause does not excuse a party's non-performance entirely, but only suspends it for the duration of the FM. The firm has to give notice of FM as soon as it occurs and it cannot be claimed ex-post facto. There may be a FM situation affecting the purchase organization only. In such a situation, the purchase organization is to communicate with the supplier along similar lines as above for further necessary action. If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of FM for a period exceeding 90 (Ninety) days, either party may at its option terminate the contract without any financial repercussion on either side.

Notwithstanding the punitive provisions contained in the contract for delay or breach of contract, the supplier would not be liable for imposition of any such sanction so long as the delay and/or failure of the supplier in fulfilling its obligations under the contract is the result of an event covered in the FM clause.
