SCOPE OF WORK AND WORKS SPECIFICATIONS

1. BHEL shall hand over area at BHEL Hospital located in BHEL Township Jhansi for establishment of **Pathology Lab/X- Ray Centre** in BHEL Jhansi Hospital premises.
2. The allotment will be done through tender process. The criteria for deciding the successful bid will be lowest overall cost to BHEL.
3. The working space for Pathology Lab/X- Ray Centre shall be provided free of cost. The party shall undertake to abide by the terms and conditions contained in the allotment letter by BHEL for the allocated premises. Other charges like electricity charges, water charges and cleaning charges will be applicable as per tender / BHEL policy.
4. The bidders will be required to quote their rates for various pathological / radiological tests in a sealed price bid as per prescribed format of tender.
5. The successful bidder will be awarded license for running the Pathology Lab/X- Ray Centre for a period of **3 (Three)** years. This period may be extended for a further on mutual **consent basis**.
6. The successful bidder (hereinafter referred to as “Licensee”) shall maintain record of all the tests done during the month. Only the tests which are referred by BHEL Doctors will be put up for payment by the licensee.
7. The Licensee shall carry out the pathological tests / X-Ray for the cases referred to it by BHEL Doctors as per standard online referral system / any other system duly notified by BHEL. The document specifying the test to be performed will be generated by BHEL Hospital and sent to the licensee through mail / by hand and based on this testing is to be carried out. No money is to be charged from the BHEL employees who have been referred by BHEL Doctors. The licensee will maintain a record of all referrals and send the invoice for the same to BHEL.
8. At the end of every month, the licensee will generate consolidated invoice and send to BHEL Medical Superintendent. Medical Superintendent will, after due verification of the invoice and all supporting documents forward the bill to Finance Department for payment.

9. Payment will be made within 30 days (Thirty days) from the receipt of the invoices complete in all respects. All statutory formalities shall have to be complied with. The payment will be made only to the bank account through EFT (Electronic Fund Transfer).in this regard, necessary forms for EFT shall be submitted.
10. The Licensee shall deploy its manpower with requisite educational qualifications based on the clinical requirement.
11. The Licensee shall give the following details of their manpower deployed at the Lab. Name of employee, Address, Contact details, Qualification, Experience, Type of employment and the remuneration part. shall be solely responsible for payment of wages, statutory benefits, bonus or incentives if any, etc to its employees who are deployed at Pathology Lab/X- Ray Centre Lab set up in the BHEL premises.
12. The proposed facility/lab shall be restricted to BHEL employees (both serving and retired) and their dependants.
13. Licensee shall set up the phlebotomy area at the peripheral of BHEL city dispensaery at address 333/3 Jhokan Bagh,Jhnasi-284001 and the samples will be transported to the lab at BHEL Hospital for the analysis.
14. Licensee shall employ a phlebotomist at the BHEL City Dispensary, from 9:00 AM to 11:30 AM on alternate days basis (i.e Monday, Wednesday and Friday).
15. Licensee shall keep runner boy to collet and carry the samples from BHEL city dispensay to the processing lab at Hospital Lab.
16. Normally Timing for X-Ray and Pathology BHEL Hospital at Khailar will be from 8:00 AM to 7:00 PM (6 days in a week) but in case of emergency necessary support is to be provided 24X7.
17. Center closing days: Pathology Lab/X- Ray Centre Lab shall be closed on Sundays, National Holidays, BHEL Holidays.

18. The Licensee shall ensure that the investigations are being done as per the standard protocol as per NABL requirement.
19. The Licensee may be owner of Hospital with NABL accredited Pathology Lab or owner of NABL accredited Diagnostic centre.
20. Instruments proposed for installation should have valid calibration certificate.
21. The Licensee shall set up the Installation of High-end Medical Diagnostic Facility at their cost at the given premises.
22. The Licensee shall install, validate and commission the Immunoassay Machine, Electrolyte Analyzer, 5 Part Hematology Analyzer, ESR Analyzer, HbA1C Analyzer etc based on the sample load.
23. Once the sample load is sufficient enough for Pathology Lab/X- Ray Centre to have viable operation, the Microbiology facility shall be established in the Processing lab at BHEL Hospital-Jhansi.
24. If samples need to be transported to other Pathology Lab/X- Ray Centre locations for Specialty tests or any other tests due to unavoidable reasons, the licensee shall bear the cost of logistics of the sample transportation.
25. The Licensee shall ensure that all the samples transportations if any are being carried out as per NABL- protocol
26. The Licensee shall invest at its own costs for the necessary software support system required for the operation of the lab.
27. The Licensee shall be ready to integrate the LIS used at BHEL with their HMIS for transferring the data.
28. The Licensee shall release the Lab reports within the specified timeline (TAT) as mutually agreed with BHEL.
29. BHEL agrees to provide permission for the manpower deployed by The Licensee for the Lab services.

30. The Licensee shall make arrangements for all statutory requirements related to establishment, maintenance, renewal in relation to Lab and equipment. However, in case of any documents need to be produced by BHEL shall be submitted by BHEL for compliance purpose.
31. BHEL will allow The Licensee to use the Bio-medical waste management system available at BHEL hospital.
32. In case of any dispute arises, either of the parties shall have the right to terminate the agreement after giving 03 (three) month's Written notice to the other party. Payment if any due to The Licensee shall be paid within 60 days from such date of termination.
33. In the event of termination, The Licensee agrees to hand over peaceful vacant possession of the premises occupied by them and neither The Licensee nor its employees shall be entitled to claim any money or other sum or damage or wages from BHEL.
34. If any test whose cost is beyond the contract rate of BHEL, prior permission / consent should be taken from M.S. of BHEL, Jhansi.
35. Interested parties may visit BHEL Hospital, Jhansi for discussion about the establishment of Pathology Lab / X- Ray Centre at BHEL, Hospital Jhansi.
36. Tenders received late /in open condition / not meeting the tender condition / incomplete in any respect are likely to be rejected.
37. BHEL will not be responsible for the postal delay under any circumstances for non-receipt of Tenders by due date & time.
38. BHEL has the right to reject all or any of the tenders and accept any tender(s) irrespective of its / their being the lowest / highest.
39. If any information/ documents submitted by the tenderer are found false/fake at any stage, the document submitted by tendere will not be considred for evaluation.

40. The offer of the bidders who are on the banned list as also the offer of the bidders, who engage the services of the banned firms, shall be rejected. The list of the banned firms is available on BHEL web site www.bhel.in.
41. **The bidder shall quote the discount percentage in English language and international numerals ONLY. The rates shall be entered in figures as well as in words. Rates shall be considered up to TWO decimal points only. Digits beyond TWO decimal points will be ignored and not rounded off. No representations on this account shall be entertained.**
42. **The Bidders are required to quote for the complete scope of services. Tenders for part of the services or incomplete in any respect are liable to be rejected.**
43. **Discount percentage quoted by the bidder will be firm for the contract period or extended period of contract. No price variation and escalation due to increase in labour / material cost will be allowed.**
44. **The discount percentage quoted by the bidder are after considering all cost, cost of site clearance and any other incidental works required to execute the services and inclusive of all including GST.**
45. Bid should be free from correction, overwriting, using corrective fluid, etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection.
46. If the discount percentage is not filled in the Price Bid and is not as per the requirement of the tender document, the same shall be omitted from evaluation.
47. The discount percentage should be indicated both in words and figures. All entries in the Tenders must be written in ink or typewritten.
48. **VALIDITY OF RATES:** Validity of rates will be **120 days** from the date of opening of the techno- commercial bid.
49. **EVALUATION CRITERIA:** The criteria of evaluation of techno-commercial bids will be on the basis of documents submitted by the bidders. Along with the scrutiny of the documents in line with tender terms & conditions, BHEL reserves the right to visit the dispensaries/ clinic/ hospital of the Bidder to assess and confirm their credibility. The criteria of evaluation of techno-commercial bids shall be on the basis of documents submitted by the Bidders. BHEL may finalize successful tenderer by **opening of sealed price bid**. Date of opening of sealed Price Bid will be intimated, by e-mail separately to the Bidders who qualify in the Techno-Commercial bid. The decision of BHEL will be final in this regard. The order will be placed on the Bidder, who quotes maximum discount percentage on the BHEL scheduled rates. Evaluation of bid will be on total cost to 'BHEL'.
50. **CORRECTION OF ARITHMETIC ERRORS:** Provided that the bid is substantially responsive, BHEL shall correct arithmetical errors on the following basis:

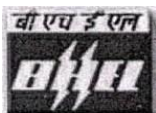

51. If there is a discrepancy between words and figures, the amount in words shall prevail.
52. If any bidder does not accept the correction of errors, their bids are liable to be disqualified.
53. You should ensure the equipment to be provided under the contract against perils like fire, earthquake, theft, high voltage etc. i.e. your own cost.
54. **PENALTY FOR INFERIOR QUALITY OF SERVICES:** BHEL reserves the right to inspect the services of Pathology/X-ray treatment provided to the employees of BHEL. In case BHEL finds the Services as unsatisfactory the contractor will be penalized as per follows: -

55. **CONTRACT PERIOD:** The contract period will be for **Three (03) years** from the date of award which can further be extended further on the same rates, terms & conditions on the mutual agreement between the company and the Bidder on satisfactory performance of the contract and will be decided later.
56. **SUBLETING:** The Contractor shall not sublet, transfer or assign the full work or any part thereof to any other person/company/organization.
57. **TAXES AND DUTIES:**
- To enable BHEL to avail GST input tax credit, contractor shall submit GST compliant Tax invoice containing all the particulars as stipulated under invoice Rules of GST Law. Payment shall be made to the contractor only after submission of GST complaint Tax invoice. The successful bidder shall raise GST compliant invoice affixing GSTIN of BHEL's unit availing the services.
 - BHEL reserves the right to protect its interest against any loss on account of availability of GST credit.
 - GSTIN of BHEL is "09AAACB4146P2ZC".
 - Any new/ change in statutory levy as and when made applicable by the Government shall become applicable against documentary evidence.

- v. Payment to the contractor will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act & GST, as amended from time to time and a certificate to this effect shall be provided to the contractor by BHEL.
- vi. Invoice submitted should be in the format as specified under GST Laws viz. all details as mentioned in Invoice Rules like GSTIN registration number, invoice number, quantity, rate, value, taxes with nomenclature – CGST, SGST, IGST mentioned separately, HSN (Harmonized System of Nomenclature) Code/ SAC (Services Accounting Code) Code etc.
- vii. The Contractor has to give an undertaking that GST as mentioned in the invoice has been/ will be paid and also file returns as per respective extant rule.

58. **ELECTRICITY CHARGES:**

- a. The **Bidder shall** provide Pathology/X-ray facility to the employees of the BHEL, both serving and retired and their eligible family members, at a discount of percentage as quoted in the price bid on BHEL Schedule rates.
- b. **Electricity for lab/X-ray center will be provided by BHEL on Commercial rates as per actual meter reading.**

59. **PAYMENT TERMS:**

- a) The Bidder/ Contractor shall raise the bill on BHEL at the end of every month for services provided for the respective month.
 - b) Bills raised by the Bidder/ Contractor shall be certified by the official in-charge of BHEL and the payments will be made **within 30 (Thirty) days** from the date of receipt of GST complaint Tax invoice (if applicable) having no discrepancy and other relevant documents.
 - c) The Bidder/ Contractor shall not be entitled to any interest with respect to any money which may be due to him from BHEL.
 - d) The quoted rates will remain firm during the contract period except taxes as applicable by the Government against documentary evidence.
 - e) The successful bidder shall submit the bank details along with the cancelled cheque for NEFT/RTGS.
60. Accommodation in any manner will not be provided to the workers of the contractor deployed in the execution of work.
61. No party shall be permitted to tender for work in BHEL in which any of their near relatives is an employee connected with the award and execution of the contract. They shall also intimate the names of persons who are working with them in any capacity or subsequently employed by them and who are near relatives of any employee of the BHEL. Any violation of this condition which comes to the Notice of the BHEL after the contract is awarded will entitle the BHEL to treat the

- contractors as having committed a breach of contract and to exercise all the rights and remedies available to the BHEL on account thereof.
62. BHEL looks forward to get excellent services from the bidder. The contractor will be responsible for the quality of the work.
63. The bidder along with its associate/ collaborators/ sub-contractors/ sub-bidders/ consultants/ Bidders shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
64. **TERMINATION OF CONTRACT:** BHEL may terminate the contract by giving not less than thirty day's written notice of termination to the successful tenderer for the following reasons: -
- If the successful tenderer does not remedy a failure in performance of their obligation under the contract, within thirty days after being notified.
 - In the event of external factors (like natural disaster) which are beyond the control of the contractor or BHEL.
 - In case the personnel deployed by the contractor found to have indulged in any criminal activity.
 - In case of any misrepresentation while claiming the payment.
 - In the event of failure/ inability of one party or the other.
 - In case of non-compliance of any statutory obligations during the contract.
 - Without prejudice to any of the rights or remedies under this contract, if the contractor dies, the accepting officer shall have the option of terminating the contract without compensation to the contractor's survivors.
65. **SECURITY OF CONFIDENTIAL INFORMATION:** The bidder(s)/contractor agree & acknowledge that in the course of their discussions and interaction, BHEL may disclose information of confidential proprietary nature relating to its business, products, know-how, technology, customers, employees and financial to the bidder(s)/contractor. Such information shall be considered as confidential. The contractor agrees to keep it confidential & secret at all times and not directly or indirectly disclose to any party other than its employees and authorized personnel's strictly on a need know basis, without the prior written permission of BHEL.
66. **RECOVERY FROM CONTRACTOR:** Whenever under the contract, any sum of money shall be recoverable from or payable by the contractor, the same may be deducted from any sum then due or which at any time thereafter may become due to the contractor under the contract or under any other contract with BHEL or the contractor shall pay the claim on demand without any terms & conditions.
67. **FORCE MAJEURE:** A Force Majeure (FM) means extraordinary events or circumstance beyond human control such as an event described as an Act of God (like a natural calamity) or events such as war, strike, riots, crimes (but not

including negligence or wrong-doing, predictable/seasonal rain and any other events specifically excluded in the clause). An FM clause in the contract frees both parties from contractual liability or obligation when prevented by such events from fulfilling their obligations under the contract. An FM clause does not excuse a party's non-performance entirely, but only suspends it for the duration of the FM. The firm has to give notice of FM as soon as it occurs and it cannot be claimed ex-post facto. There may be a FM situation affecting the purchase organization only. In such a situation, the purchase organization is to communicate with the supplier along similar lines as above for further necessary action. If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of FM for a period exceeding 90 (Ninety) days, either party may at its option terminate the contract without any financial repercussion on either side.

Notwithstanding the punitive provisions contained in the contract for delay or breach of contract, the supplier would not be liable for imposition of any such sanction so long as the delay and/or failure of the supplier in fulfilling its obligations under the contract is the result of an event covered in the FM clause.

68. **POST TECHNICAL AUDIT OF WORK AND BILLS:** BHEL reserves the right to carry out a post payment audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc. and to enforce recovery of any sums becoming due as a result thereof in the manner provided into the proceeding sub-paragraph provided however, that no such recovery shall be enforced after three years of passing the final bill.

69. **SETTLEMENT OF DISPUTES:**

- a. **CONCILIATION:** if at any time (whether before, during or after the arbitral or judicial proceedings), any disputes (which term shall mean and include any dispute, difference, question or disagreement arising in connection with construction, meaning, operation, execution, effect, interpretation or breach of the Contract, which the Parties are unable to settle mutually, arise inter-se the Parties, the same may be referred by either Party to Conciliation to be conducted through Independent Experts Committee (IEC) to be appointed by competent authority from the BHEL Panel of Conciliators.

The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration & Conciliation Act, 1996 or any statutory modification thereof and as provided in the BHEL Conciliation Scheme as applicable from time to time.

- b. **ARBITRATION:** In the event of any dispute arising between the parties hereafter referred as BHEL and Contractor in respect of or connected with this contract, General & Special terms & conditions of tender, then the same

shall be referred to Arbitration and Arbitrator will be nominated by the Head of Unit of BHEL JHANSI, whose decision shall be final and binding on both the parties. However, any differences or doubt pertaining to meaning/ interpretation of any phrase word used in terms or in the schedule of services, their nature and manner of rendering of such services shall be the excepted matter and be referred to the Head of unit of BHEL JHANSI, whose decision shall be the final and binding. The provisions of Arbitration and Conciliation Act, 1996 or any statutory modification and re-enactment thereof will apply to such arbitration provided however, in all matters the venue of proceedings will be Jhansi and only Jhansi or appropriate Courts will have jurisdiction over the same.

70. RISK CLAUSE:

BHEL reserves the right to terminate the contract due to any failure on the part of the Contractor in discharging his obligations under the contract or in the event of his becoming insolvent or going into liquidation. The decision of the BHEL about the failure on the part of the Contractor shall be final and binding on the Contractor. 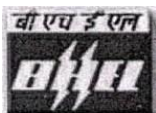

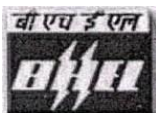

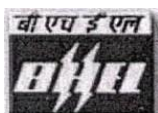
