1.1) Average Annual financial turnover from during the last 3 years, ending 31st March, 2022 should be at least Rs. 1.34 Lakh of the estimated cost. Duly audited Financial Statement/ Balance sheet / Certificate from CA to be submitted as a supporting document.

1.2) If all balance sheets are not available for all three years than the average shall be calculated by dividing the sum of turnover of submitted balance sheets by three.
