A- Overhauling related activities

1. Opening of all furnace manhole doors, duct manhole doors, ESP manhole doors (field and hoppers) and chimney manhole doors.
2. Removal of all ash deposits in boiler cavity, duct, wind-box, ESP and chimney.
3. Cleaning of fluidizing beds, pinning of air nozzles and application of cast able refractory wherever required.
4. Tube cleaning and leak test of APH.
5. Manual/air cleaning of economizer, air-preheater and ESP fields from duct side.
6. Cleaning of FD, ID and PA fans suction chamber by blowing compressed air & refit after cleaning.
7. Ensuring ID, FD, PA fans IGV dampers cleaning and freeness.
8. Bearing inspection and alignment of all ID, FD and PA fans.
9. Inspection and realignment of boiler feed water pumps.
10. Insulation and sheeting works for damaged insulation in ESP inlet duct, feed-water line, Deaerator pegging line.

11. Opening the manhole doors of deaerator, manual cleaning and removal of debris.
12. Make sure that all the removed parts & open doors have been fitted properly with sealing & Gasket to avoid any leakage.
13. Rectification/replacement of ESP CE and EE rapping hammers.

B- Hydraulic Test related activities

1. Opening the manhole doors of lower and upper drums, manual cleaning and removal of debris.
2. Removal of main steam stop valve and drum safety valve. Removal of any settled debris.
3. Clearing of any choked steam or water line and normalization for inspection.
4. After above work produce boiler for dry test/open inspection to boiler inspection authority.
5. After open inspection of boiler by boiler inspection authority, all manhole door for upper and lower drum to be closed with gasket.
6. Main steam stop valve and drum safety valves flanges to be fixed with dummy plates and gaskets. Any other provision for dummy or isolating the lines to be done for any required isolation for hydraulic test.
7. After above work do the hydraulic testing of boiler in presence of boiler inspection authority.
8. After hydraulic testing install safety valves and main steam stop valve with gasket. Any other arrangement done for hydraulic test to be normalized.

Note: Dry & hydraulic test of the boiler shall be carried out as per directions received by boiler inspector & it can also be done on same day.

- 1. Co-ordination with the office of boiler inspector for carrying out open inspection/dry test & hydraulic test of the boiler as per IBR is in scope of supplier. However, all statutory fee as per IBR rules shall be paid by BHEL to IBR office.**
2. Contractor has to take the work permit from engineer in-charge, before starting the work.
3. Contractor has to ensure the working of their staff safely by issuing them safety items like hand gloves, marking cloth, safety belts, nose mask, safety goggles etc.
4. The contractor has to work during the night as well as during holidays and Sundays according to the exigencies of the works.
5. Contractor shall depute competent supervisor for the satisfactory completion of all mentioned works in co-ordination with BHEL representative.
6. Contractor has to arrange manpower & tools for the work. All the tools required for the above work shall be in the scope of the contractor.
7. Tentative period for boiler overhauling (Reg. No. UP 7709) during the contract period will be in the month of August 2024. However, overhauling schedule is indicative and likely to be changed as per the requirement.
