Terms and condition

- 1. Scope of work covers comprehensive maintenance of all type of air conditioners as mentioned in BOQ, their maintenance / repair work including supply and fitting of all the required spares.
- 2. The L-1 offer shall be decided on overall lowest price based on offered price by the bidder as per qty. of work mentioned in 'Format of Price Bid". BHEL has right to conduct reverse auction instead of open price bid to determine L-1 offer.
- 3. Contractor shall provide and replace all spare parts as may be required in the equipment (except Physical damage) to keep all the equipment in proper working condition throughout the CMC period. Hence, vendor to ensure and maintain adequate stock of all the required spares including consumables.
- 4. All complaints will be intimated through phone calls or e-mails and are required to be resolved within 24 Hours of intimation. Non-completion of required work within stipulated time shall attract suitable penalty.
- 5. Rates: Rates for CMC shall remain fixed & valid for throughout the period of contract.
- 6. Breakdown restore schedule: Service response time by the contractor against breakdown notice of BHEL shall be the essence of the contract. Hence, breakdown/service requirement of any item must be attended & resolved within 24 Hours (BHEL off days excluded) of intimation by BHEL through e-mail/phone. Contractor shall furnish its service report for all its routine & breakdown maintenance. In case of major breakdowns of compressor failure or motor burnt/ damage and PCB card burnt, the complaint shall be resolved within 3 working days.
- 7. Shortcomings, if any, in the work executed by the Contractor will be pointed out by the designated employee to the Contractor or his authorized representative and the same shall be rectified by him within I day to the satisfaction of the designated employee.
- 8. Penalty: 5 times of per day CMC charge (considering 365 days/year) will be deducted from vendor bills/dues if problem is not restored as per breakdown restore schedule against complaint.
- 9. Risk Purchase: In case of unsatisfactory services or contractor does not carry out the fulfils the obligations of the contract in part or full, BHEL, in order to safeguard its interest under the contract, may get the services/repair/replacement of spares done at its own discretion, through suitable alternative source(s) at risk & cost of the contractor. In such cases, any cost incurred to BHEL over and above contracted rates shall be recovered from dues payable to the contractor and no claim of compensation of loss, whatsoever, incurred by the contractor due to such recovery, shall be entertained / compensated by BHEL.
- 10. Operation months for air conditioners with stabilizer shall be 6 summer months (May to October) i.e., From 05.05.2022 or date of award of work (whichever is later). Last date for End of Contract shall be 31 October of Contract Year or end of Six months from contract date(whichever is earlier).
- 11. BHEL Rudrapur is located in rat prone area, Vendor will be responsible for repair of all Rat damaged parts and wiring.
- 12. Payment Terms: Payment shall be made on monthly basis within 45 days against submission of GST invoice along with monthly service reports.
- 13. Security deposit (SD): Security Deposit shall be as applicable.
- 14. All the materials/ spares, tools and tackles required for resolving the breakdowns as well as routine servicing will be in the scope of the contractor.
- 15. Faulty / Damaged spare parts have to be returned to BHEL and shall be retained by BHEL.
- 16. The price breakup of total amount quoted by the party shall be done to derive the cost and rate of individual activity as given in BOQ cum price distribution sheet (Annexure-II).
- 17. BHEL reserves the following rights
 - a. To accept/reject any or all tenders without assigning any reason therefor.
 - b. To terminate the contract at any time without assigning any reason therefore by giving a notice of 15 days.

18. Contractor shall be responsible for providing safety equipment/ safety shoes/ Helmet/ Safety belt etc. for their Manpower attending Complaint in BHEL premises. Non-compliance of any requirement shall attract irrevocable monetary penalty of Rs. 50/day.
