12. DELIVERY SCHEDULE: -

For Jhabua: Delivery Completion shall be in Feb' 2013 i.e Four (04) months from date of Purchase Order (PO).

For Rayalseema: Delivery Completion shall be in March 2013 i.e Six (06) months from date of Purchase Order (PO).

The above deliveries for both the projects are subject to bidder's 1st submission of drawing/docs within 10 days from the date of PO. Vendor to re-submit Drg/Docs within 7 days, taking care of all the comments of BHEL / (End) Customer. BHEL shall approve/ comment on drgs./ docs. within 7 days. **BHEL shall approve all Drg/Docs in Cat-I in total 1 months' time from the date of PO.** Any deficiency in documents submitted w.r.t. agreed specification/ comments from BHEL shall be treated as non-submission and no. of days delay in submission of complete documents during approval process, on account of this, would be reduced from the delivery. The vendor shall be responsible for getting approval from BHEL as early as possible and BHEL will support the process, in full, within above time frame and terms & conditions. If required bidder's representative should visit BHEL / (End) CUSTOMER for approval of Drg/Docs.

13. Above delivery shall be on FOB basis for foreign vendors & FOR dispatch station for Indian vendors. Hence two separate Price schedule will be prepared.
14. **As per GCC Rev 05 Clause No. 15.0 (page 9 of 11) :** BHEL/PEM reserve the right to go for reverse auction through BHEL appointed service provider, instead of opening the sealed bid submitted along with Part-I. This would be decided after techno-commercial evaluation.
15. Evaluation and Ordering shall be done on Project wise basis on overall L1 (Total cost to BHEL) basis
16. O&M spares and Training of Engineers are optional items. O&M spares and Training of Engineers may be used for evaluation and ordering based on customer confirmation which shall be confirmed before Reverse Auction/Price bid opening.
17. Package may be Air lifted instead of shipping through sea hence foreign bidders to quote both the price (i.e FOB with Sea Worthy Packing and FOB with air worthy packing (Optional)) for GCB-Jhabua. BHEL will inform which price shall be considered for evaluation before Reverse Auction/Price Bid Opening.
18. Indian bidders will be informed to quote freight charges in percentage of ex-works.
19. The Indian bidders to note and confirm the following payment requirement:
"Submission of E1/E2 forms against Form C is to be ensured within the time specified in sales tax act or before balance 10% payment whichever is earlier." In case of non-acceptance by any bidder, commercially loading of 10% of Ex-works shall be done.
