- 9.0 Assessment of Capacity of Bidders: Void
- 10.0 Since the job shall be executed at site, bidders must visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation, applicable wage structure, wage rules, etc before quoting for this tender. All the Four conditions shall be fulfilled in the invoice before release of service tax, Swachh Bharat Cess & Krishi Kalyan Cess.
