- 1.1 Bidders to quote their competitive monthly hiring charge for One or More Vehicle Type both in figure and in words in prescribed format of "Price Bid".
- 1.2 The quoted monthly hiring charge shall include the cost of engine oil, cost towards driver like wage, allowances, food, accommodation and conveyance, etc., cost of maintenance and repair work required for the Bus, cost of comprehensive vehicle insurance, RTO passing, road permit, etc. required for the normal movement in the route from Miryalguda to our project site. Any other cost shall also be considered inclusive except for clause 1.3 below.
